## **RESOLUTION NO. R2014-52**

A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL AMENDING THE BUDGET FOR FISCAL YEAR 2014 BY INCREASING THE REVENUE BUDGET IN THE RECREATION IMPACT CAPITAL FUND AND UNASSIGNING CAPITAL PROJECT EXPENSE BUDGETS IN THE RECREATION IMPACT, GOVERNMENTAL AND GAS TAX CAPITAL FUNDS THROUGH SEPTEMBER 30, 2013; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the FY 2014 Recreation Impact Capital Fund revenue budget was adopted in the amount of \$563,000; and

**WHEREAS,** actual Recreation Impact Fee revenues are expected to exceed the budget by \$50,100 through September 30, 2014; and

**WHEREAS**, the amended budgets for the ten capital projects in Budget Amendment 2014-073 total \$4,576,985 including balances brought forward from prior years; and

**WHEREAS**, the description and scope of the ten capital projects and programs shown in Exhibit "A" are revised since the original assignment of the capital funds and the budgeted amounts exceed the revised funding need in each project through September 30, 2014; and

WHEREAS, a Budget Amendment, attached as Exhibit "A", has been prepared in accordance with Section 6 of Wellington's Charter and in compliance with §166.241 (4) (c) Florida's Statutes adding \$50,100 to the Recreation Impact Capital Fund revenue and reassigning \$2.27 million in existing capital project expenditure budgets to the associated capital fund balances; and

**WHEREAS,** Wellington's Manager recommends approval of the Budget Amendment.

NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL that:

**SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true and correct.

**SECTION 2.** The Wellington Council hereby approves the Budget Amendment #2014-073 as set forth in Exhibit "A" and authorizes the Mayor to execute the
