- Question: Sheet C-3 shows a sidewalk 26' long. Sheet C-4 does not show it, which is correct?
   Response: The 26' long sidewalk shown on C-3 is correct and needs to be installed. In addition, a sidewalk and street crossing are shown on C-4 but not on C-3. This street crossing needs to be installed.
- 2. Question: The proposal form #3 calls for 4" thickness. Sheet S-3 shows 6" RC slab. Note #7 calls for 6 x 6 W2-9 WWM. Section 2 of S2A call for #3 @ 12" O.C. Please, does the sidewalk receive reinforcing? Please clarify. Response: For the proposal, the bid form has been updated to include separate line items for the sidewalk and the 6" concrete pads (picnic area, water fountain, and trash cans).

Note 7 has been adjusted to read: 6" SOG shall be reinforced as indicated on detail 2/S3.

Sidewalk does not receive rebar or mesh. Construction joints shall be provided per detail on C-5, Detail 2.

- 3. Question: Sheet C-4 shows signage, crosswalk, etc. 5' High Fence, where is this cost placed on the bid form? Response: Attached to Addendum Two is the revised Schedule of Values. The Schedule of Values have been updated to include the following:





In order to provide services or goods to Wellington, we require that you provide us either proof of workers compensation coverage or proof of exemption.

Employers conducting work in the State of Florida are required to provide workers' compensation insurance for their employees. Specific employer coverage requirements are based on the type of industry, number of employees and entity organization. To determine coverage requirements for a specific employer, the following information is provided by the Bureau of Compliance.

**Construction Industry** - One (1) or more employees, including the owner of the business who are corporate officers or Limited Liability Company (LLC) members. For a list of the trades considered to be in the construction industry see 69L-6.021 Florida Administrative Code.

Non-Construction Industry - Four (4) or more employees, including business owners who are corporate officers or Limited Liability Company (LLC) members.
