Pursuant to the foregoing notice, a Regular Meeting of the Wellington Council was held on Tuesday, August 26, 2025, commencing at 6:30 p.m. at Wellington Village Hall, 12300 Forest Hill Boulevard, Wellington, FL 33414.

- 1. CALL TO ORDER Mayor Napoleone called the meeting to order at 6:30 p.m.
- **2. INVOCATION** Father Steven Thomas, Retired Rector of St. David's in the Pines Episcopal Church, delivered the invocation.

Representative Anne Gerwig, District 93, and Brenda Bryant (Legislative Aide) on behalf of Senator Lori Berman/District 26, spoke about the appropriation in the amount of \$650,000 for the Wellington Pump Station Improvements Project. Mr. Barnes introduced the item.

Ms. Hall read Ordinance No. 2025-22 by title.

Tim Stillings, Director of Planning and Zoning, stated this was initiated due to Senate Bill 1388. He said the bill adopted the "Watercraft Energy Source Freedom Act". Mr. Stillings explained the amendment.

Mr. Stillings stated this amends and clarifies definitions for property maintenance. It does not change any regulations and reinforces the implementation of interpretations to date.

A motion was made by Councilman McGovern, seconded by Vice Mayor Siskind, and unanimously passed (5-0) to Approve Ordinance No. 2025-23 (Amending Chapter 13 ("Offenses And Miscellaneous Provisions"), Article 1. ("Property Maintenance"), Sections 13-1 To 13-3) as presented on first reading.
