

FOURTH ADDENDUM TO THE LAW ENFORCEMENT SERVICE AGREEMENT
SHERIFF RIC L. BRADSHAW AND WELLINGTON

This Fourth Addendum to the Law Enforcement Service Agreement is made by and between The Village of Wellington (hereinafter referred to as “Wellington”), located in Palm Beach County, and Ric L. Bradshaw, Sheriff of Palm Beach County, Florida (hereinafter referred to as “Sheriff”). Wellington and the Sheriff shall hereinafter be referred to as the “Parties.”

WHEREAS, the Parties executed a Law Enforcement Service Agreement effective October 01, 2014, a First Addendum effective October 01, 2015, a Second Addendum effective October 01, 2016, and a Third Addendum effective October 01, 2017, (the “Agreement”), by which the Sheriff agreed to perform law enforcement services; and

WHEREAS, the Parties wish to set forth the consideration for the Fourth Year of the Contract Term, October 01, 2018 through September 30, 2019.

NOW, THEREFORE, in consideration of the mutual covenants herein contained the receipt and sufficiency of which are hereby acknowledged, it is agreed upon as follows:

1. In accordance with Article 5, Section 5.2 of the Law Enforcement Service Agreement, Section 5.1 is amended as to the total amount due for services for the period beginning October 01, 2018 through September 30, 2019 as follows: The total cost of personnel and equipment shall be \$9,541,602.00. Monthly payments shall be \$795,133.50.
2. In all other respects and unless otherwise stated, the terms and conditions of the Agreement, shall continue unchanged and in full force and effect.
