**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL
APPROVING A SPECIAL USE PERMIT FOR THE ANNUAL GPL
POLO EVENT UTILIZING OUTDOOR AMPLIFIED MUSIC TO BE
HELD AT 3665 120th AVENUE SOUTH; AND PROVIDING AN
EFFECTIVE DATE.**

WHEREAS, Isla Carroll Farm, LP, located at 3665 120th Avenue South in Subarea D of the Equestrian Overlay Zoning District, will be hosting their Annual GPL Polo Event on Saturday, April 2, 2016 from 11:00 a.m. to 7:00 p.m.; and

WHEREAS, GPL Polo event has been held in Wellington for seven (7) years and has received a Special Use Permit for the event every year since 2010; and

WHEREAS, the event is a one (1) day polo event with live entertainment including a disc jockey with outdoor amplified music; and

WHEREAS, the event is anticipated to have approximately 1,100 people in attendance with parking provided on the stick and ball field to the south within the International Polo Club; and

WHEREAS, Article 5, Chapter 5. Special Use Permits, Section 5.5.2 of the Wellington Land Development Regulations requires the Council to review all Special Use Permits with amplified music; and

WHEREAS, the Special Use Permit application has been reviewed by Wellington staff, Palm Beach Sheriff's Office, Palm Beach County Fire Rescue and is recommended for approval.

NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL
that:

SECTION 1. The foregoing recitals are hereby affirmed and ratified.

SECTION 2. The Wellington Council hereby approves the Special Use Permit (Exhibit A) allowing Isla Carroll Farms, LP, to host their Annual GPL Polo Event located at 3665 120th Avenue South on April 2, 2016.

SECTION 3. This Resolution shall become effective immediately upon adoption.
