12	WHEREAS, on August 23, 2011, Council approved the Law Enforcement		
13	Services Agreement (Agreement) effective October 1, 2011 for a period of five years		
14	subject to approval by Council of annual budget proposals by the Sheriff's Office to		
15	provide law enforcement services for the Village of Wellington; and		
16			
17	WHEREAS, Article 5.2 of the Agreement provides that the total amount due for		
18	all law enforcement services for subsequent years shall be based upon the proposal		
19 20	submitted by the Sheriff's Office during the Village's budget process and approved by the Village Council; and		
20 21			
21	WHEREAS, the total amount of compensation for the Fiscal Year 2013/2014 was		
22	\$8,135,346.00, which reflected an increase of 2% or \$151,579.62 and a staffing		
24	increase of one (1) Detective Sergeant, one (1) Detective and one (1) Deputy Sheriff at		
25	an annual increase of \$404,785 and a total contract sum of \$8,135,346.00, as set forth		
26	in the Second Addendum to the Law Enforcement Services Agreement; and		
27			
28	WHEREAS, the total amount of compensation for the Fiscal Year 2014/2015		
29	reflects an increase of approximately 1% or \$81,353.00 with no staffing increases for a		
30	total annual contract sum of \$8,216,699.00, as set forth in the Third Addendum to the		
31	Law Enforcement Services Agreement, attached hereto as Exhibit "A"; and		
32			
33	WHEREAS, Staff recommends that the Village Council approve the proposed		
34	Third Amendment to the Law Enforcement Services Agreement between the Village of		
35	Wellington and the Palm Beach County Sheriff's Office.

37	NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S

39 40	SECTION 1. The foregoing recitals are hereby affirmed and ratified as being true
