> Mr. Barnes mentioned that in the abundance of caution staff has asked our esteemed guest to attend the Agenda Review meeting for the first items listed on the Agenda under Presentations and Proclamations. He said that in the event that we have to change the order of the operations in terms of how we conduct the meeting as it relates to the storm.
