| 42 43 44 45 46 | SECTION 5: Should any section, paragraph, sentence, clause, or phrase of any prior Wellington Ordinance, Resolution, or Municipal Code provision, then in that event the provisions of this Ordinance shall prevail to the extent of such conflict. |
