Sadowski Affordable 12 Housing Act, Chapter 92-317 of Florida Sessions Laws, allocating a portion of 13 documentary stamp taxes on deeds to local governments for the development and 14 maintenance of affordable housing; and 15 16 **WHEREAS**, the State Housing Initiatives Partnership (SHIP) Act, ss. 420.9076, 17 Florida Statutes, requires local governments to adopt annual housing incentives reports; 18 and 19 20 WHEREAS, the Affordable Housing Advisory Committee has reviewed, 21 evaluated, and identified incentives and recommendations in efforts to remove 22 regulatory barriers that limit the development or preservation of affordable housing; and 23 24 WHEREAS, the Planning and Zoning Department has prepared the required 25 annual housing incentives report for submission to the Florida Housing Finance 26 Corporation; and 27 28 WHEREAS, the Affordable Housing Advisory Committee, after notice and public 29 hearing on October 29, 2025, has reviewed the 2025 AHAC Housing Incentives Report 30 and made a recommendation for approval with a unanimous vote (8-0); and 31 32 WHEREAS, the Wellington Council finds that it is in the best interest of the public 33 for the Village of Wellington to approve the 2025 AHAC Housing Incentives Report and 34 submit the report to the Florida Housing Finance Corporation for approval. 35 36 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S 37 **COUNCIL** that: 38 39 **SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true 40 and correct. 41 SECTION 2.
