

NOTICE OF PUBLIC HEARING  
VILLAGE OF WELLINGTON  
COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM  
FISCAL YEAR 2020/2021 ANNUAL ACTION PLAN

The Village of Wellington is an entitlement recipient of Community Development Block Grant (CDBG) funds authorized under Title I of the Housing and Community Development Act of 1974, as amended (Public Law 93-383, as amended).

The Village of Wellington received notification from the U.S. Department of Housing and Urban Development (HUD) that it will receive a FY 2020 CDBG entitlement allocation of \$291,425 for use during the Village of Wellington's fiscal year beginning October 1, 2020, and ending September 30, 2021.

The Village proposes to use its CDBG entitlement allocation for the following activities:

• Housing Rehabilitation Loan Program.....	\$ 71,570
• Rental Assistance Program.....	\$ 71,570
• Senior Transportation and Rides (STAR) Program.....	\$ 40,000
• Youth Mentoring/Employment Program.....	\$ 50,000
• Planning and Administration .....	\$ 58,285
 Total CDBG funded activities .....	\$ 291,425

Consistent with the Citizen Participation requirements at 24 CFR Part 91.105 and the Citizen Participation Plan adopted by the Village of Wellington, the Village encourages citizens to comment on the FY 2020/2021 CDBG Annual Action Plan.

A 5-day public comment period will begin on August 4, 2020, and end on August 10, 2020. Copies of the FY 2020/2021 CDBG Annual Action Plan are available in the Planning, Zoning and Building Department at 12300 Forest Hill Boulevard, Wellington, FL 33414, between the hours of 8:00 a.m. and 1:00 p.m. Monday thru Thursday, or by appointment. Citizens are encouraged to comment on the Village's FY 2020/2021 CDBG Annual Action Plan by submitting written comments to the Planning, Zoning and Building Department at 12300 Forest Hill Boulevard, Wellington, FL 33414, or to [planninginfo@wellingtonfl.gov](mailto:planninginfo@wellingtonfl.gov).

The Village of Wellington will conduct a public hearing to receive citizen comment and to approve the FY 2020/2021 CDBG Annual Action Plan. The public hearing will take place on Tuesday August 11, 2020.
