29 30 31 32	<b>SECTION 2.</b> All previous fee schedules established by Resolution, Policy, or otherwise relating to facilities are superseded by provisions of this Resolution and are of no further effect.
33 34 35 36 37	<b>SECTION 3.</b> For purposes of this Resolution and administering fee schedules adopted herein, a resident is any person who lives within the Village of Wellington boundaries on more than a transient basis (as the term is defined within the Village's Land Development Regulations). All other persons seeking to utilize the facilities shall be considered non-resident.
38 39 40 41 42	<b>SECTION 4.</b> Should any section, paragraph, sentence, clause, or phrase of this Resolution be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Resolution as a whole or any portion or part thereof, other than the part to be declared invalid.
42 43 44 45	<b>SECTION 5.</b> The amended Fee Schedule for Facilities, attached hereto as Exhibit "A", is hereby adopted.
46 47	<b>SECTION 6.</b> This Resolution shall become effective immediately upon adoption.
