**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL
ADOPTING A FACILITIES FEE SCHEDULE; PROVIDING A
REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE;
AND PROVIDING AN EFFECTIVE DATE.**

WHEREAS, Chapter 38 of the Code of Ordinances of the Village of Wellington authorizes the Village Council to set regulations for the use of its facilities and adopt fee schedules; and

WHEREAS, the Village of Wellington has been developing and operating parks, recreation, and other facilities attendant thereto since becoming a Village; and

WHEREAS, the Village currently has fees in place for the rental of facilities; and

WHEREAS, new facilities have been added or made available for rent by the public; and

WHEREAS, a fee schedule for facilities has been developed and is attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL that:

SECTION 1. The foregoing recitals are hereby affirmed and ratified as being true and correct.

SECTION 2. All previous fee schedules established by Resolution, Policy, or otherwise relating to facilities are superseded by provisions of this Resolution and are of no further effect.

SECTION 3. For purposes of this Resolution and administering fee schedules adopted herein, a resident is any person who lives within the Village of Wellington boundaries on more than a transient basis (as the term is defined within the Village's Land Development Regulations). All other persons seeking to utilize the facilities shall be considered non-resident.

SECTION 4. Should any section, paragraph, sentence, clause, or phrase of this Resolution be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Resolution as a whole or any portion or part thereof, other than the part to be declared invalid.

SECTION 5. The amended Fee Schedule for Facilities, attached hereto as Exhibit "A", is hereby adopted.

SECTION 6. This Resolution shall become effective immediately upon adoption.
