

THIRD ADDENDUM TO THE LAW ENFORCEMENT SERVICE AGREEMENT
SHERIFF RIC L. BRADSHAW AND WELLINGTON

This Third Addendum to the Law Enforcement Service Agreement is made by and between The Village of Wellington (hereinafter referred to as “Wellington”), located in Palm Beach County, and Ric L. Bradshaw, Sheriff of Palm Beach County, Florida (hereinafter referred to as “Sheriff”). Wellington and the Sheriff shall hereinafter be referred to as the “Parties.”

WHEREAS, the Parties executed a Law Enforcement Service Agreement effective October 01, 2021, a First Addendum effective October 01, 2022, and a Second Addendum October 01, 2023, (the “Agreement”), by which the Sheriff agreed to perform law enforcement services; and

WHEREAS, the Parties wish to set forth the consideration for the Fourth Year of the Contract Term, October 01, 2024 through September 30, 2025.

NOW, THEREFORE, in consideration of the mutual covenants herein contained the receipt and sufficiency of which are hereby acknowledged, it is agreed upon as follows:

1. In accordance with Article 5, Section 5.2 of the Law Enforcement Service Agreement, Section 5.1 is amended as to the total amount due for services for the period beginning October 01, 2024 through September 30, 2025 as follows: The total cost of personnel and equipment shall be \$11,297,752.00. Monthly payments shall be \$941,479.33. The last monthly payment shall be \$941,479.37.

2. Article 5, Section 5.3, regarding additional law enforcement services of the Law Enforcement Service Agreement is amended and shall now read as follows:

Additional law enforcement services as set forth in Article 2, Section 2.1 (E) shall be compensated at the rate of \$116.00 per hour and will be billed by the Sheriff to Wellington on a monthly basis. This rate is subject to annual review and change upon agreement between Wellington and the Sheriff. Alternatively, Wellington may opt to submit an application for an off-duty permit.

3. In all other respects and unless otherwise stated, the terms and conditions of the Agreement, which includes prior Addenda, shall continue unchanged and in full force and effect.

IN WITNESS WHEREOF, the Parties hereto have executed the Addendum to the Agreement as of the last date all signatures below are affixed.
