Subject: Sales Surtax Revenue & Expenditure Report

The purpose of this memo is to provide the Parks & Recreation Advisory Board with the Sales Surtax Revenue and Expenditure report for the meeting.

As of August 31, 2023, the Village of Wellington collected \$5,099,027 in Surtax revenues on a \$4,905,024 budget or approximately 104% of budgeted revenues. Since inception, Wellington has collected \$32,348,557 in Surtax revenues. In addition, the Village has earned \$562,499 in investment earnings from 2017-2023. The Village has provided additional funding (transfers in less transfers out) of \$7.1 million to cover project expenses.

The collection of the Sales Surtax ends the earlier of December 31, 2026 or upon receiving approximately \$38,863,050 in collections for the Village of Wellington.

The capital expenditures for the period ended August 31, 2023 are outlined below for each surtax project with project budget.

- Greenview Shores Park (aka WCHS project) has incurred expenses of \$40,716. Village Council awarded contracts totaling \$12,212,904 to Kaufman Lynn and Kimley Horn for construction and construction administration. The Grand Opening was on June 16, 2021 at the beautiful new complex! Additional expenses included softball batting cages and field equipment.
- Town Center Phase II: Village Council approved the Kaufman Lynn Construction Inc. contract for Phase II construction February 22, 2022 with an estimated cost of \$8,283,733. Phase II which included construction of the Amphitheater and Scott's Place expansion was completed in May 2023.
- Aquatics Complex: In January 2023, the Village awarded a contract to Ohlson Lavoie Corporation for Architectural & Engineering Services in the amount of \$1.9 million, of which \$1,020,301 has been expensed to date.
