I am proud to nominate **Detective Michael Barbusio** for the **2025 Village of Wellington Top Cop award** in recognition of his exceptional service, professionalism, and investigative skill. He consistently exemplifies the highest standards of law enforcement and fully embodies what it means to be a "Top Cop."

Detective Barbusio has over eight years of law enforcement experience, including the past six serving the Village of Wellington, where he also resides. Known for his tireless work ethic and investigative expertise, he is frequently called upon to assist local, state, and federal partners. His contributions and collaborative efforts are second to none.

In 2024, Detective Barbusio led or co-led 134 cases, including vehicle and residential burglaries, retail thefts, and fraud. His efforts resulted in a 31.3% clearance rate — more than double the national average of 13.9% for property crimes.

One particularly complex case highlights his investigative skill and tenacity. The case began with the theft of three luxury vehicles from a seasonal resident's home. Despite the challenges posed by the victim residing in a different time zone, Detective Barbusio quickly recovered one vehicle in Lake Worth Beach and developed a suspect who was apprehended in Wellington driving a separate stolen vehicle. His subsequent investigation linked the suspect to multiple residential burglaries within the village. Consent to search the victim's residence led to the discovery of the suspect's personal vehicle hidden in the garage, and evidence showed the suspect had changed the home's locks. Further investigation into the suspect's social media revealed posts referring to the residence as her "new home" and listings of stolen property matching items from a third burglary. A residential search warrant resulted in the recovery of evidence from all three burglary scenes, including the altered door locks.

The suspect was ultimately charged with four residential burglaries, three stolen vehicles, and multiple theft-related offenses. Although offered a plea deal of seven years, the suspect declined and now faces up to 140 years in prison with all cases set for trial — a result made possible through Detective Barbusio's exemplary work.

Detective Barbusio's dedication to solving crime, serving his community, and supporting fellow law enforcement professionals makes him truly deserving of this recognition. I wholeheartedly recommend him for the 2025 Village of Wellington Top Cop award.

#### **Key examples of his exemplary service include:**

- Case #25035057: After a suspect fled during a traffic stop, Deputy Finne conducted followup interviews, identified the offender, and uncovered involvement in drug sales. This led to an arrest warrant and the recovery of marijuana and methamphetamine.
- Case #25045813: During a self-initiated stop, he discovered a concealed Taurus .38 revolver. The driver, age 20, was arrested—preventing potential future violence.
- Case #25048265: A vehicle search revealed marijuana, multiple pill bottles, and \$1,500 in cash. The suspect, on probation, was arrested for possession with intent to sell. A phone search confirmed illegal drug distribution through text messages.

In addition to these cases, Deputy Finne consistently conducts effective field interviews, generating actionable intelligence shared with District 8, District 15, and PBSO Narcotics. His efforts have significantly supported regional drug enforcement operations.

Beyond enforcement, Deputy Finne mentors newer deputies, sharing his experience and reinforcing PBSO's core values of service and integrity. His leadership elevates his team and enhances the agency's effectiveness.

I respectfully nominate **Deputy Sheriff Davis Malvinni** (ID# 35063) for the **Top Cop Award for the Village of Wellington**. Deputy Malvinni has consistently demonstrated exceptional initiative, professionalism, and a steadfast commitment to public service, making him an indispensable asset to District 8. His strong work ethic, proactive approach to policing, and dedication to keeping the community safe are evident in his day-to-day performance and the impactful results he achieves.

Over the past year, D/S Malvinni has played a critical role in several high-profile investigations and arrests, including:

- Felony Retail Theft (Case# 25-024928): Investigated a theft at Best Buy, identified the suspect through bulletin dissemination and photo lineups, secured a warrant, and effected an arrest. The suspect—convicted of 17 prior thefts—was sentenced to 364 days in jail.
- Counterfeit Tag/Narcotics Arrest (Case# 25-022582): During a traffic stop, discovered a counterfeit license plate and 7.12g of cocaine. Arrested the driver for possession of cocaine and third offense DWLS.
- Tag Theft Suspect Identified & Arrested (Case# 24-104638): Recalled a suspect from a prior encounter and, with assistance from community members, quickly located and arrested the offender.
- **AK-Style Firearm & Narcotics Seizure (Case# 24-054097):** Conducted a traffic stop resulting in the recovery of 578g marijuana, cocaine, paraphernalia, and a loaded AK-style pistol. Multiple felony charges were filed.
- Dangerous Golf Cart Pursuit (Case# 24-076406): Identified and apprehended a suspect who recklessly fled on an unsafe golf cart, charging him with fleeing/eluding and resisting arrest.

These incidents reflect Deputy Malvinni's keen investigative instincts, solid understanding of criminal behavior, and dedication to maintaining a high level of community safety. His ability to combine proactive enforcement with professionalism and sound judgment continues to have a meaningful impact on our residents and the overall success of District 8 operations.

D/S Malvinni's consistent performance and integrity embody the core values of the Palm Beach County Sheriff's Office. For these reasons, I strongly support his nomination for **the** *Top Cop* **Award** and believe he is most deserving of this recognition.
