DECLARATION OF EASEMENT (CORRECTIVE DOCUMENT)

THIS DECLARATION OF EASEMENT, made this 2117 day of October,
1975 by ALCOA FLORIDA, INC. ("AFT") and BREAKWATER HOUSING CORP. ("Breakwater"),
both Florida corporations, and ACME IMPROVEMENT DISTRICT ("Acme") (formerly
Acme Drainage District) a Drainage District under the laws of the State of
Florida (AFI, Breakwater and Acme are hereinafter collectively referred to as
the "Declarants") provides:

WHEREAS, the Plat of PALM BEACH LITTLE RANCHES EAST OF WELLINGTON (the "Plat") recorded on March 27, 1974 in Plat Book 30, pages 158 and 159 of the Public Records of Palm Beach County, Florida, shows certain Drainage Easements and Utility Easements thereon; and

WHEREAS, the Dedication by Declarants, the owners of the parcel of land shown on said Plat, omitted to dedicate said easements; and

WHEREAS, that certain Declaration of Restrictions (the "Restrictions") dated February 4, 1972 recorded on February 12, 1972 in Official Record Book
1977, page 1105 of said public records, executed by AFI (successor by merger to Alpha Beta, Inc.) and Breakwater, created certain easements in
Article 11. thereof, specifically an easement in a strip of land ten (10) feet wide within all boundary lines of the Tracts of Palm Beach Little Ranches East of Wellington, for utilities and drainage purposes except on the West boundary of Tracts 1 through 12, inclusive, where said easement is eighty (80) feet wide; and

WHEREAS, AFI and Breakwater want to assign such easements to Acme and any public service corporation which may require the use of said right-of-way.

NOW, THEREFORE, for and in consideration of the premises:

1. Declarants hereby dedicate the Drainage Easements shown on the Plat to Acme, in fee simple; provided, however, that in the event Acme ceases to exist or to have the authority to maintain the Drainage Easements, then in that event, said Drainage Easements shall revert to First Wellington, Inc.,

a Florida corporation not for profit, and shall be maintained by said corporation not for profit, as provided for in the Articles of Incorporation thereof, which have heretofore been recorded upon the public records of Palm Beach County, Florida.

- 2. Declarants hereby dedicate the Utility Easements shown on the Plat to the perpetual use of the public for the construction and maintenance of Public Utilities and/or Drainage Purposes.
- 3. AFT and Breakwater hereby: (i) assign the Easements shown in Article 11. of the Restrictions as being eighty (80) feet wide to Acme for Drainage Purposes; and (ii) hereby assign the Easements shown in Article 11. of the Restrictions as being ten (10) feet wide to the perpetual use of Acme and the public for the construction and maintenance of Public Utilities and/or Drainage Purposes.
