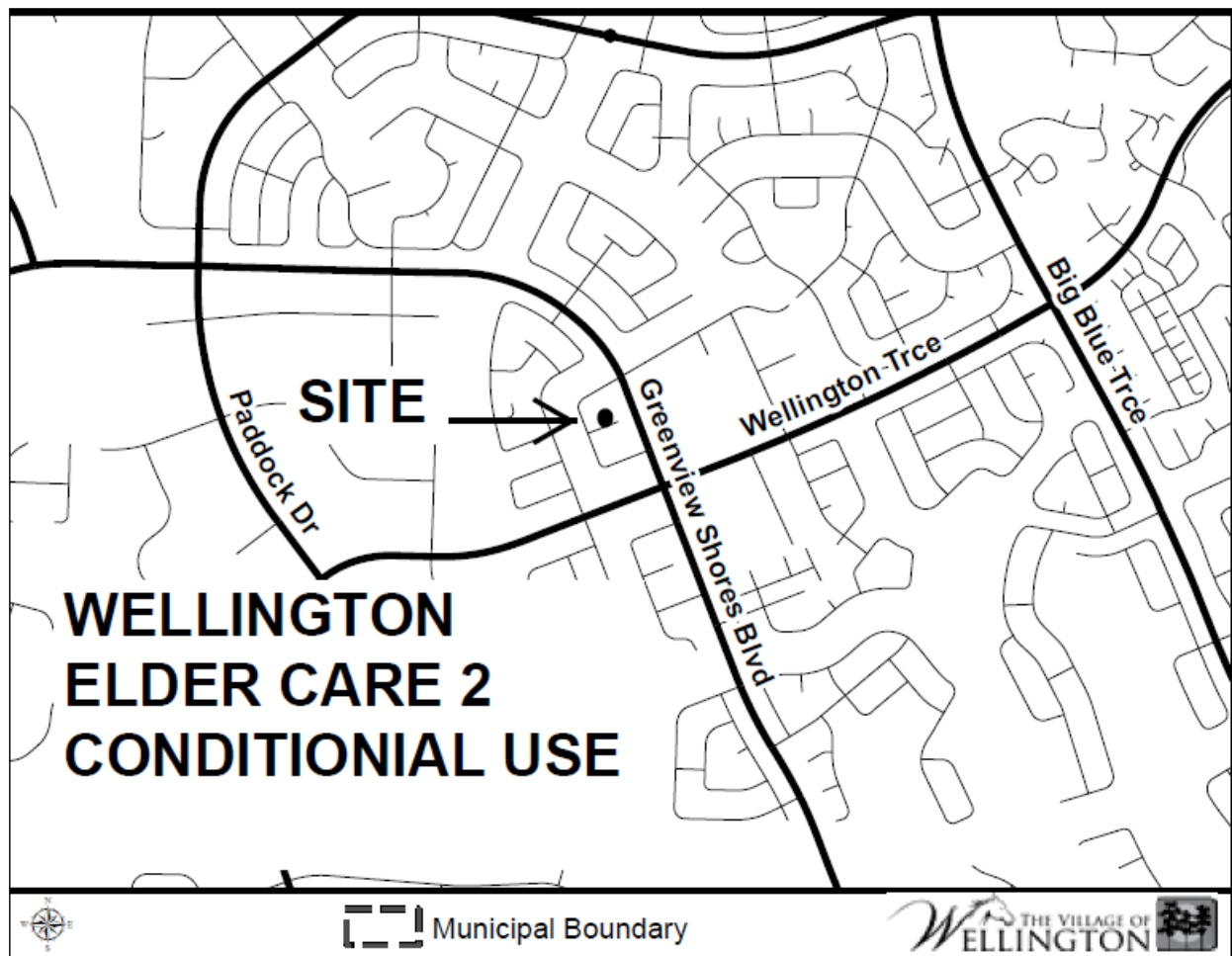




**VILLAGE OF WELLINGTON
