# SPECIAL MEETING OF THE WELLINGTON VILLAGE COUNCIL

Pursuant to the foregoing notice, a Special Meeting of the Wellington Council was held on Wednesday, July 16, 2025, commencing at 4:30 p.m. at Wellington Village Hall, 12300 Forest Hill Boulevard, Wellington, FL 33414.

Council Members present: Michael J. Napoleone, Mayor; Tanya Siskind, Vice Mayor; John T. McGovern, Councilman; and Amanda Silvestri, Councilwoman.

Council Members absent: Maria Antuña, Councilwoman.

Advisors to the Council: Jim Barnes, Manager; Laurie Cohen, Village Attorney; Tanya Quickel, Deputy Village Manager; Ed De La Vega, Assistant Village Manager; and Chevelle D. Hall, Village Clerk.

- 1. CALL TO ORDER Mayor Napoleone called the meeting to order at 4:30 p.m.
- 2. PLEDGE OF ALLEGIANCE Mayor Napoleone led the Pledge of Allegiance.
- 3. APPROVAL OF AGENDA

Mr. De La Vega indicated staff recommended approval of the Agenda as presented.

A motion was made by Councilman McGovern, seconded by Vice Mayor Siskind and unanimously passed (4-0), to approve the Agenda as presented.

#### 4. SPECIAL AGENDA ITEM

A. 25-7244 APPROVAL OF AMENDMENT TO ARTICLE 3, SECTION 3.2 OF THE PURCHASE AND SALE AGREEMENT WITH WELLINGTON PROPERTY OWNER LLC TO EXTEND THE DEADLINE FOR THE INSPECTION PERIOD TO SEPTEMBER 30, 2025

Mr. De La Vega introduced the item.

Ms. Cohen discussed the deadline for the inspection period in the original Purchase and Sale Agreement (PSA) with Wellington Property Owner, LLC and relayed information from staff discussions with the Related Group about the reservoir parcel. She mentioned that during Related's environmental analysis there were issues that came up and they are trying to work through those issues.

Councilman McGovern inquired about the direction the Village would go.

Mayor Napoleone clarified that this is an extension for the Related Group to work out two issues regarding the reservoir and environmental due diligence on the rest of the property. He commented about extending the deadline.

Ms. Cohen stated two months will give the parties time to negotiate a resolution to the issue.

Anjuli Panse, Utilities Director, stated the reservoir parcel is not a part of any stormwater system and utilizes reclaimed water. She reviewed the process and talked about the ponds in the Village. Ms. Panse explained the irrigation function.

Mayor Napoleone inquired about irrigation of the pond and the park.

Ms. Panse responded to Mayor Napoleone's question pertaining to the irrigation of the park.

Ms. Cohen stated the negotiations have not taken place yet.

Mr. George A. Pincus, Esq, Stearns Weaver Miller Weissler Alhadeff & Sitterson, P.A., discussed his recommendation for the amendment and stated the other dates in the PSA agreement remains the same. He commented about the congruity of both of the agreements (Related and the School).

Kevin Ryan discussed the concurrency as it relates to the school property. He spoke about the provision for the irrigation and mentioned extra acreage.

Councilman McGovern queried about the irrigation and connection.

Ms. Panse said there is an existing horizontal directional drill.

Councilman McGovern asked about the Department of Environmental Protection.

Mr. Ryan gave a brief summary regarding the results of environmental testing for the project.

Councilman McGovern inquired about Mr. Pincus's experience with this and other matters and the next deadline after this one.

There was further discussion between the Village Council, Ms. Cohen, Mr. Pincus, Mr. Ryan and Maximillian Kaye regarding the environmental aspects, irrigation, deadlines, number of extensions, approvals process and timelines.

Ms. Cohen referenced the two minor wording changes in the amendment that was placed in Council's amendments folders.

A motion was made by Councilman McGovern, seconded by Vice Mayor Siskind, and unanimously passed (4-0) to approve the 1<sup>st</sup> Amendment to the Purchase and Sale Agreement as provided in the amendments folder.
