RESOLUTION NO. R2025-42

A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL TO AMEND THE EXHIBIT B ATTACHED TO THE LOCAL AGENCY PROGRAM AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION FOR GREENBRIAR BOULEVARD REBUILD & BICYCLE LANES PROJECT; AND PROVIDING AN EFFECTIVE DATE.

10 **WHEREAS**, achieving a safe, convenient, and efficient non-motorized 11 transportation system of pedestrian ways and bicycle ways is a component of Objective 12 1.1 of the Transportation Element of Wellington's Comprehensive Plan; and 13

14 WHEREAS, on March 11, 2025, Council Agenda File # 25-7020 was brought 15 before Council for Approval and Council Approved Resolution R2025-11 to enter into a Local Agency Program Agreement with the Florida Department of Transportation for 16 17 Greenbriar Boulevard Rebuild & Bicycle Lanes Project (see Exhibit A). Florida Department of Transportation notified Wellington that they would be voiding the 18 19 previously partially executed LAP Agreement for the Greenbriar Boulevard Rebuild & 20 Bicycle Lanes Project and reissued another Agreement with changes limited only to Exhibit B (see Exhibit B and Exhibit C). There are no changes to the overall funding 21 22 amount; however, all funding will now be moved to Fiscal Year 2025, eliminating the 23 previous split between FY 2025 and FY 2026.

WHEREAS, The Village of Wellington desires to enter into the amended Local Agency Program Agreement between the Village of Wellington, Florida and the State of Florida, Department of Transportation to provide for the Department's participation in the Greenbriar Rebuild & Bicycle Lanes Project; and

WHEREAS, The State of Florida, Department of Transportation agrees to participate in the project up to the maximum amount of \$2,714,026.00 and funds in the amount of \$1,371,243.00 are available in the Village of Wellington's Road & Pathway Circulation Expansion Program for the projected balance of the cost of the project; and

WHEREAS, Wellington's Manager recommends that Wellington's Council approve and authorize the Mayor to enter into and execute the amended Local Agency Program Agreement on behalf of the Village; such Agreement is attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S
COUNCIL that:
