RESOLUTION NO. 2024-52

**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL
AUTHORIZING THE MAYOR AND CLERK TO EXECUTE
AN AGREEMENT BETWEEN WELLINGTON AND
REDSPEED FLORIDA LLC TO PROVIDE THE TRAFFIC
REPORT SERVICES FOR THE VILLAGE'S SCHOOL
ZONES, AND TO INSTALL AND OPERATE THE SDS
SYSTEMS ON BEHALF OF THE VILLAGE TO ENFORCE
SCHOOL ZONING SPEEDING VIOLATIONS; AND
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, Chapter 2023-174, Laws of Florida, authorizes municipalities to use speed detection systems to enforce school zone speeding violations in excess of 10 miles over the posted speed limit (among other things) during certain times and days (the "SDS Systems"); and

WHEREAS, Wellington's Council has determined that it is in the best interest of Wellington to implement a speed detection program in its designated school zones; and

WHEREAS, Wellington requires a vendor to provide traffic report services for the Village's school zones, and to install and operate SDS Systems on behalf of the Village to enforce school zone speeding violations as authorized by law; and

WHEREAS, Wellington is a member of the Southeast Florida Governmental Purchasing Cooperative Group; and

WHEREAS, the Southeast Florida Governmental Purchasing Cooperative Group appointed the City of Plantation as the lead agency for matters related to procurement of a Speed Detection System for school zones; and

WHEREAS, the City of Plantation, through its competitive selection process, awarded RFSP No. 005-24 to RedSpeed Florida, LLC for the purpose of providing a turnkey automated school zone safety program; and

WHEREAS, Staff recommends that Council enter into an agreement with Redspeed Florida, LLC to provide these services; and

WHEREAS, the implementation of a speed detection program will protect the safety of Wellington's school children while creating positive revenue for Wellington.

NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL that:

SECTION 1. The foregoing recitals are hereby affirmed and ratified as being true
