ORDINANCE NO. 2024-15 1 2 3 AN ORDINANCE OF WELLINGTON, FLORIDA'S COUNCIL, 4 AMENDING THE WELLINGTON CODE OF ORDINANCES 5 CHAPTER 13, ARTICLE II (NOISE STANDARDS), SECTIONS 13-4 6 7 TO 13-8, TO PROVIDE DEFINITIONS AND CLARIFY PERMISSIBLE SOUND LEVELS AS MORE SPECIFICALLY CONTAINED HEREIN; 8 9 PROVIDING Α CONFLICTS CLAUSE; **PROVIDING** SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE. 10 11 WHEREAS, the Wellington Council, as the governing body, pursuant to the authority 12 vested in Chapter 166, Florida Statutes, is amending the Code of Ordinances to amend 13 the noise standards to address public health, safety, and welfare; and 14 15 WHEREAS, certain activities and the associated noise, particularly activities on 16 residential property, require noise levels greater than that of a normal conversation to be 17 regulated and enforced to ensure the peaceful enjoyment of land; and 18 19 20 WHEREAS, Wellington's Council has taken the comments from the public into 21 consideration of the proposed amendments that are the subject of this Ordinance. 22 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF WELLINGTON, 23 **FLORIDA THAT:** 24 25 **SECTION 1.** Chapter 13, Article II (Noise Standards), Sections 13-4 to 13-8 of the 26 Code of Ordinances, Wellington, Florida, is hereby amended as specifically provided in 27 28 Exhibit A. 29 30 **SECTION 2.** Should any section, paragraph, sentence, clause, or phrase of this ordinance conflict with any section, paragraph, clause, or phrase of any prior Wellington 31 32 ordinance, resolution, or municipal code provision, then in that event, the provisions of this 33 ordinance shall prevail to the extent of such conflict. 34 35 **SECTION 3.** Should any section, paragraph, sentence, clause, or phase of this ordinance be declared by a court of competent jurisdiction to be invalid, such decision shall 36 not affect the validity of this ordinance as a whole, or any portion of part thereof, other than 37 38 the part so declared to be invalid. 39 40 [This section is intentionally blank.] 41
