## 2 AN ORDINANCE OF WELLINGTON, FLORIDA'S COUNCIL 3 AMENDING THE WELLINGTON CODE OF ORDINANCES, MORE 4 SPECIFICALLY, TO MODIFY AND CLARIFY CERTAIN PROVISIONS 5 IN CHAPTER 21 (TAXATION) RELATED TO BUSINESS TAX 6 7 RECEIPTS (BTR), AS CONTAINED HEREIN; TO ESTABLISH THE FINDINGS AND IMPLEMENTATION OF BTR; PROVIDING A 8 9 CONFLICTS CLAUSE; PROVIDING A SEVERABILITY CLAUSE; 10 AND PROVIDING AND EFFECTIVE DATE. 11 WHEREAS, Wellington, a Florida Council, as the governing body, pursuant to the authority 12 vested in it by Article VII, section 2 of the Florida Constitution, and Chapter 166 of the Florida Statutes, 13 is authorized and empowered to adopt and amend legislation to govern the affairs of its citizens; and 14 15 WHEREAS, Wellington adopts modifications to the Code of Ordinances periodically as 16 17 necessary to protect the health, safety, and welfare of the community; and 18 19 WHEREAS, Wellington believes that it is in the best interest of the community to make 20 modifications to Chapter 21 (Taxation), more specifically, Article II [Local Business Tax Receipt (BTR)] of the Code of Ordinances to adopt clarifications, definitions, and process specifically related to BTRs, 21 as provided in Exhibit A of this ordinance: and 22 23 24 WHEREAS, the proposed amendment to clarify and provide guidance to support and retain 25 existing businesses and to be responsive to the local business community; and 26 27 WHEREAS, Wellington's Council has taken the Finding of Facts from Wellington staff, 28 competent substantial evidence presented at the hearing, and comments from the public into 29 consideration when considering the proposed amendment. 30 31 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF WELLINGTON, FLORIDA, 32 THAT: 33 **SECTION 1.** Chapter 21 of the Code of Ordinances, more specifically Article II (Local Business 34 35 Tax Receipt), is amended as provided in Exhibit A of this Ordinance. 36 37 **SECTION 2.** Should any section, paragraph, sentence, clause, or phrase of this ordinance conflict with any section, paragraph, sentence, clause, or phrase of this ordinance, resolution, or 38 municipal code provision, in that event the provisions of this ordinance shall prevail to the extent of 39 40 such conflict. 41 **SECTION 3.** Should any section, paragraph, sentence, clause, or phrase of this ordinance be 42 declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of 43 44 this Ordinance as a whole or any portion or part thereof, other than the part so declared to be invalid. 45 46 **SECTION 4.** Notice of the proposed ordinance was published fifteen (15) days prior to the first 47 reading and has met statutory requirements; therefore, this ordinance shall be effective upon second 48 reading and adoption. 49 50 51 52 The remainder of this page is intentionally left blank. 53
