JLA Geosciences Inc. (JLA) reviewed four (4) bid packages provided by State of Florida certified water well contractors for the Village of Wellington (Village) Invitation to Bid (ITB) #202524 - Water Reclamation Facility Class I Injection Well System Mechanical Integrity Testing.

Bids were publicly opened and recorded on October 21, 2025, at 11:00 AM. A summary of the bid results is provided below:

Bidder	Total Bid Price
All Webbs Enterprises, Inc.	\$86,400.00
Layne Christensen Company	\$114,390.00
A.C. Shultes of FL, Inc.	\$122,600.00
Florida Design Drilling, LLC	\$124,900.00

All Webbs Enterprises, Inc. (AWE) submitted the lowest bid at \$86,400.00 which is \$27,990.00 lower than the next lowest bid submitted by Layne Christensen Company.

JLA's review for this recommendation was limited to the Bid Schedule of Values provided for each bidder. Based on this review, the bid submitted by AWE was found to be responsive, and the pricing presented is considered reasonable and within the expected cost range for this type of well construction and testing work.
