R2024-52** 2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL AUTHORIZING THE MAYOR AND CLERK TO EXECUTE 4 5 AGREEMENT BETWEEN WELLINGTON AND REDSPEED FLORIDA LLC TO PROVIDE THE TRAFFIC 6 7 REPORT SERVICES FOR THE VILLAGE'S SCHOOL 8 ZONES, AND TO INSTALL AND OPERATE THE SDS 9 SYSTEMS ON BEHALF OF THE VILLAGE TO ENFORCE 10 ZONING SPEEDING SCHOOL **VIOLATIONS:** AND PROVIDING AN EFFECTIVE DATE. 11 12 13 14 WHEREAS, Chapter 2023-174, Laws of Florida, authorizes municipalities to use 15 speed detection systems to enforce school zone speeding violations in excess of 10 miles over the posted speed limit (among other things) during certain times and days 16 17 (the "SDS Systems"); and 18 19 WHEREAS, Wellington's Council has determined that it is in the best interest of 20 Wellington to implement a speed detection program in its designated school zones; and 21 22 WHEREAS, Wellington requires a vendor to provide traffic report services for the 23 Village's school zones, and to install and operate SDS Systems on behalf of the Village 24 to enforce school zone speeding violations as authorized by law; and 25 26 WHEREAS, Wellington is a member of the Southeast Florida Governmental 27 Purchasing Cooperative Group; and 28 29 WHEREAS, the Southeast Florida Governmental Purchasing Cooperative Group 30 appointed the City of Plantation as the lead agency for matters related to procurement 31 of a Speed Detection System for school zones; and 32 33 WHEREAS, the City of Plantation, through its competitive selection process. 34 awarded RFSP No. 005-24 to RedSpeed Florida, LLC for the purpose of providing a 35 turnkey automated school zone safety program; and 36 37 WHEREAS, Staff recommends that Council enter into an agreement with 38 Redspeed Florida, LLC to provide these services; and 39 40 WHEREAS, the implementation of a speed detection program will protect the 41 safety of Wellington's school children while creating positive revenue for Wellington. 42 43 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S 44 **COUNCIL** that:
