Single Family Owner and Rental Properties

In response to a Council request, code compliance data for single-family, owner-occupied properties and single-family, rental properties for fiscal years 2013 and 2014 was analyzed. There are an estimated 1,482 single-family, rental properties in Wellington. As Wellington has no formal count or registration program for single-family rental properties, the estimate is based upon three assumptions; (1) utility account holders for single family indicating they are renters, (2) owners with multiple homes in Wellington not homesteaded, and (3) homes owned by limited liability companies, limited partnerships, and other companies or corporations. Wellington currently has 17,744 total single-family homes. Below is the compiled information:

Research indicates corporate ownership of single-family homes in Wellington is increasing. Currently, there are approximately 12 entities with multiple homes in Wellington totaling 228 units (approximately 15% of the total single-family, rental units. These units are purchased as an investment. The typical business plan is to rent the units until the housing market rebounds sufficiently to warrant the sale of the units.
