Dear Ms. Panse:

The Contract Documents for the Truck Canopy Rehabilitation were advertised on April 12, 2024. A pre-bid meeting was held on April 25, 2024. One addendum was issued for this project. The bid opening was held on May 14, 2024. One proposal was received by the Village of Wellington (Village) and the bid summary is provided as an Attachment.

The Town provided the bid proposal for the sole bidder, FSV Construction Company, for review. The bid proposal was evaluated for the proposed Contractor's overall technical ability to perform the work. Our review did not include a determination of bidder responsiveness, which was performed by the Village.

Hazen and Sawyer reviewed the references identified by the bidder, which were also reviewed by the Village. Two of the three project references were responsive. Both references that responded provided positive feedback and stated they would recommend FSV Construction Company for additional work.

We consider FSV Construction Company to be responsible and qualified to perform the work described in the contract documents. As such, we recommend award to them in the amount of \$169,950.00 for the construction of the Truck Canopy Rehabilitation Project.

We appreciate the opportunity to assist the Town this project and look forward to providing assistance during construction.
