	<b>WHEREAS,</b> Wellington's Council, after notice and public hearing, voted (_ to ) to transmit this proposed amendment to the Florida Department of Commerce in compliance with applicable provisions of the Florida Statutes governing amendments of Local Comprehensive Plans.
	NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF WELLINGTON, FLORIDA COUNCIL THAT:
	<b>SECTION 1.</b> The Wellington Comprehensive Plan Future Land Use Map (FLUM) designation for the subject property, as legally described in Exhibit A, is hereby designated as Conservation (CN).
	<b>SECTION 2.</b> The Manager is hereby authorized and directed to transmit this Comprehensive Plan Amendment to the Florida Department of Commerce pursuant to Chapter 163, Florida Statutes.

52 **SECTION 3.** The Manager is hereby directed to amend the Wellington Comprehensive Plan 53 Future Land Use Map (Exhibit B) to include the site-specific designation for the property legally 54 described in Exhibit A, including the adopted date and ordinance number pursuant to the 55 requirements of Chapter 163, Florida Statutes. 56

57 **SECTION 4.** Should any section, paragraph, sentence, clause, or phrase of this Ordinance 58 conflict with any section, paragraph, clause or phrase of any prior Wellington Ordinance, Resolution, 59 or Municipal Code provision; then in that event, the provisions of this Ordinance shall prevail to the 60 extent of such conflict.

62 **SECTION 5**. Should any section, paragraph, sentence, clause, or phrase of this Ordinance 63 be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the 64 validity of this ordinance as a whole or any portion or part thereof, other than the part to be declared 65 invalid.

66 67 **SECTION 6.** The effective date of this Comprehensive Plan Amendment shall be 31 days 68 after adoption by Wellington's Council, if there has not been a compliance challenge with the 69 Division of Administrative Hearings. If the ordinance is challenged within the 30 days after adoption, 70 the ordinance shall not become effective until the State Land Planning Agency or the Administrative 71 Commission, respectively, issues a final order determining the amendment to be compliant.
