TO HEAR AND DECIDE CODE 6 **ENFORCEMENT CASES, PURSUANT TO SECTION 2-203** 7 OF THE CODE OF ORDINANCES: AND PROVIDING AN **EFFECTIVE DATE.** 8 9 10 WHEREAS, Section 2-203 of the Wellington Code of Ordinances provides that the Wellington Council may appoint special magistrates to hear and decide cases 11 involving code violations in the same manner and to the same extent as the Code 12 Enforcement Board; and 13 14 15 WHEREAS, Ordinance No. 2012-18 established an eight (8) year term limit of 16 four (4), two (2) year terms for the Special Magistrates, stated that the amendment 17 was not to be applied retroactively to prior terms or by those special magistrates that 18 were currently retained; and 19 20 **WHEREAS**, Resolution No. R2015-43 provides that prior to a term expiration, 21 staff shall contact the Special Magistrate to ascertain if the Magistrate wishes to 22 continue to serve. If a Special Magistrate responds that he/she will not continue to 23 serve, has reached the term limit or is removed by the Village Council, a selection 24 committee shall be formed; and 25 26 WHEREAS, it has been the Village's past practice that one of the three Special 27 Magistrates principally reside and practice outside Wellington; and 28 29 WHEREAS, the current Special Magistrates have expressed an interest in 30 continuing to serve and staff therefore recommends reappointment of Special 31 Magistrates Michael Posner Esq. and Alan Zangen Esq. to serve a two year term 32 effective June 1, 2018 and ending June 1, 2020 and Special Magistrate Rafael 33 Suarez-Rivas Esq. to serve a two year term effective June 1, 2019 through June 1, 34 2021 at the hourly compensation rate of \$165.00; and 35 NOW THEREFORE BE IT RESOLVED BY WELLINGTON, FLORIDA'S 36 37 **COUNCIL THAT:** 38 39 **SECTION 1.** The above recitals are hereby affirmed and ratified as being true 40 and correct. 41 42 **SECTION 2.** The Wellington Council hereby appoints Special Magistrates 43 Michael Posner Esq. and Alan Zangen Esq. to complete their two year terms ending 44 June 1, 2020 and Special Magistrate Rafael Suarez-Rivas Esq. to serve a two year term effective June 1, 2019 through June 1, 2021 at the hourly compensation rate 45
