#### I Call to Order

- a. <u>PSC-225</u> STAFF REPORT

Ms. Coates gave the staff report. She shared the new change in leadership for the Palm Beach County Sheriff's Office District 8 being the newly appointed Captain Nicole Addazio and Lt. Robert Humphrey.

She also shared the appointment of the new Battalion District Chief Amanda Vomero for Palm Beach County Fire Rescue.

Ms. Coates informed the committee on upcoming events and meetings taking place.

## b. <u>PSC-231</u> PALM BEACH COUNTY SHERIFF'S OFFICE DISTRICT 8 WELLINGTON REPORT

Lt. Humphrey greeted and introduced himself to the committee.

He gave an introduction of his background and went on to share the recent crime trends. He shared that the deputies present at tonight's meeting are part of the Aggressive Driving Unit and that the vehicles they drive came were funded through a donation. He went on to share that in the Village, there have been mail thefts taking place and with the help of PBSO they have been able to mitigate this.

The Lt. stated that auto burglaries are still taking place and he reminded the public to continue locking their vehicles.

The Lt. shared that since the last committee meeting, Palm Beach County Sheriff's Office is currently deploying body worn cameras by the deputies. He also reminded the committee about the license plate readers and how they have been successful in recovering property.

He shared that District 8 has increased traffic enforcement throughout Wellington and how the District is also working on DUI enforcement.

Lt. Humphrey shared the current shoplifting stats. He stated that the stats are increasing because the value of grand theft has increased. This change has caused some issues and many businesses do not want to press charges.

He also shared that the District 8 deputies were recognized at the Palm Beach County Traffic Safety luncheon on June 13th.

## c. <u>PSC-230</u> PALM BEACH COUNTY FIRE RESCUE REPORT

District Chief Vomero greeted and introduced herself to the committee. Chief Vomero shared that Fire Rescue has prepared for the 2023 Hurricane Season. She went on to share the calls and response times for the last 3 months. In March, 548 calls, response time: 6min 36 seconds In April: 521 calls, response time: 6min 36 seconds In May: 535 calls, response time: 6 min 44 seconds Chief Vomero went on to share a quarterly update with the committee PSC-231 PALM BEACH COUNTY SHERIFF'S OFFICE DISTRICT 8 WELLINGTON REPORT

#### d. <u>PSC-229</u> PRESENTATION OF VISION ZERO AND SAFE STREETS

Village Engineer, Jonathan Reinsvold greeted the committee and gave some background comments about Mr. Vann Wilber. He then introduced Mr. Wilber to the committee.

Mr. Wilber gave a presentation to the committee about the Vision Zero initiatives and a matrix for how the Village of Wellington could get to zero fatalities.

After the presentation, Chief Vomero offered to give a presentation on electric vehicles and how Fire Rescue responds to this matter.

## e. <u>PSC-227</u> SELECTION OF TOP COP AND TOP FIREFIGHTER FOR 2023

Michael Arena stated he would recuse himself from the Top Firefighter nominations since he knows both nominees personally.

After committee discussion, the committee voted (1-5) for Detective Timothy Barbusio for the 2023 Top Cop award.

The committee voted (0-5) for Captain Cecilia Eaton for the 2023 Top Firefighter award.

Ms. Coates reminded the committee that the award winners will be recognized at the September 12th Council meeting.
