2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL 4 APPROVING AND AUTHORIZING THE MAYOR AND 5 CLERK TO EXECUTE THE FOURTH ADDENDUM TO THE LAW ENFORCEMENT SERVICES AGREEMENT WITH THE 6 7 PALM BEACH COUNTY SHERIFF'S OFFICE FOR LAW 8 ENFORCEMENT SERVICES: AND **PROVIDING** AN 9 **EFFECTIVE DATE.** 10 11 12 WHEREAS, since Incorporation, Wellington has contracted with the Palm Beach 13 County Sheriff's Office to provide law enforcement services for the Village of Wellington: 14 and 15 16 WHEREAS, on August 9, 2022, Council approved the First Addendum to the 17 Law Enforcement Services Agreement (Agreement) effective October 1, 2022, for a 18 period of one (1) year, expiring on September 30, 2023; and 19 20 WHEREAS, on September 5, 2023, Council approved the Second Addendum to 21 the Law Enforcement Services Agreement (Agreement) effective October 1, 2023, for a 22 period of one (1) year, expiring on September 30, 2024; and 23 24 WHEREAS, on September 3, 2024, Council approved the Third Addendum to 25 the Law Enforcement Services Agreement (Agreement) effective October 1, 2024, for a 26 period of one (1) year, expiring on September 30, 2025; and 27 28 WHEREAS, Article 5.2 of the Agreement provides that the total amount due for 29 all law enforcement services for subsequent years shall be based upon the proposed 30 costs submitted by the Sheriff during Wellington's budget process and approved by 31 Wellington's Council; and 32 33 WHEREAS, the total amount of compensation for the Fiscal Year 2024/2025 was 34 \$11,297,752.00, which reflected a 4% increase, an increase of \$434,529.00 over the 35 previous year; and 36 37 WHEREAS, the total amount of compensation for the Fiscal Year 2025/2026 is 38 \$11,803,377.00 which reflects a 4% increase for a total increase of approximately 39 \$505,625.00 over the previous year, including the addition of one (1) Sergeant, as set 40 forth in the Law Enforcement Services Agreement, attached hereto as Exhibit "A"; and 41 42 WHEREAS, Staff recommends that the Village Council approve the proposed 43 Law Enforcement Services Agreement between the Village of Wellington and the Palm
