a Municipal Corporation 400 North West 70<sup>th</sup> Avenue Plantation, Florida 33317 (Hereinafter referred to as "CITY")

and

#### ALLIED UNIVERSAL CORP.

a Florida Corporation 3901 NW 115<sup>th</sup> Avenue Miami, FL 33178 (Hereinafter referred to as "CONTRACTOR")

WHEREAS, on December 8, 2022, CITY entered into an Agreement with CONTRACTOR for Purchase and Delivery of Sodium Hypochlorite; and

WHEREAS, the initial term of this Agreement commenced on December 8, 2022 through December 7, 2023; and

WHEREAS, Section 3, Subsection 3.1A – Term, states "the CITY reserves the right to extend this Agreement for four (4) additional one (1) year renewal periods, provided the CONTRACTOR also agrees in writing to extension upon such terms as the CITY and CONTRACTOR agree"; and

WHEREAS Amendment No. 1 was executed on November 13, 2023 with an effective date December 8, 2023 – December 7, 2024 and the parties exercised its first option to renew the Agreement for an additional one (1) year period, which included a price increase in unit prices; and

WHEREAS, Amendment No. 2 was executed September 9, 2024, with an effective period of December 8, 2024 – December 7, 2025 and the parties exercised its second option to renew the Agreement for an additional one (1) year period, which included a price increase in unit prices; and

WHERAS, the current Agreement expires on December 7, 2025 with the option to renew this Agreement for an additional one (1) year period to include a price increase under the same terms and conditions; and

WHEREAS, the CITY has determined that the CONTRACTOR has performed in accordance with requirements of the Agreement and wishes to exercise/execute the third (3<sup>rd</sup>) of four (4) one (1)

year renewal options pursuant to Section 3, Subsection 3.1A (Term) of the Agreement extending the Agreement to December 7, 2026, to include a price increase under the same terms and conditions; and

WHEREAS, under this Amendment the CITY and CONTRACTOR mutually agree with amending the Agreement to extend the term of the Agreement through December 7, 2026, to include a price increase under the same terms and conditions.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, CITY and CONTRACTOR other good and valuable consideration, the receipt and adequacy of the which are acknowledged, the parties agree as follows:

#### SECTION 1. RECITALS

The foregoing recitals are true and correct and are hereby incorporated into this Agreement.

# **SECTION 2.** TERM (Section 3, Subsection 3.1A - Term)

The term of this Agreement shall be extended through **December 7, 2026**.

# SECTION 3. RESPONSIBILITIES OF CONTRACTOR SECTION 3.2, B. CONTRACTORS COMPENSATION

The amended unit prices shall be in accordance and found herein and shall remain firm through December 7, 2026.
