16	WHEREAS, due to Covid, the Market Study and related assessment was split			
17 18	into three phases that concluded in January 2023; and			
19	WHEREAS, Wellington and the Treasure Coast Regional Planning Council			
20	utilized the information in the Market Study and assessment to develop a set of master			
21 22	plan design standards; and			
22	WHEREAS, the Wellington Green Master Plan Design Standards are principles			
24	for uses, densities and intensities, connectivity, building design, and open space for the			
25 26	Multiple Use Planned Development – Pod G, also referred to as the "Egg" or Wellington			
26 27	Green; and			
28	WHEREAS, the Wellington Green Master Plan Design Standards are designed			
29 30	to serve as a guide for the redevelopment of the Multiple Use Planned Development –			
30 31	Pod G.			
32	NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S			
33 34	COUNCIL that:			
35	SECTION 1. The foregoing recitals are hereby affirmed and ratified as being true			
36	and correct.			
37 38	SECTION 2. The Wellington Council hereby approves the Wellington Green			
39	Master Plan Design Guidelines as set forth in Exhibit "A".
