

**AMENDMENT #1 TO THE AGREEMENT FOR  
HURRICANE/DISASTER DEBRIS REMOVAL, REDUCTION AND DISPOSAL  
BETWEEN SOLID WASTE AUTHORITY OF PALM BEACH COUNTY AND  
DRC EMERGENCY SERVICES, LLC  
DATED THE 25TH DAY OF APRIL 2022**

This First Amendment dated the 20<sup>th</sup> day of February, 2025, to Agreement No. 22-201D (the "Agreement"), between the Solid Waste Authority of Palm Beach County (hereinafter referred to as the "AUTHORITY") and DRC Emergency Services, LLC. (hereinafter referred to as the "CONTRACTOR" and "Parties" when referred to collectively).

**Whereas**, the Parties desire to extend the term of the Agreement for three (3) additional years as provided in Article 1 of the original Agreement. There are no further extensions permitted under the Agreement; and,

**Whereas**, the undersigned as an officer or representative of the CONTRACTOR hereby attests, declares, and affirms that it does not use coercion for labor or services as defined in Section 787.06, of the Florida Statutes, effective July 1, 2024; and

**Whereas**, AUTHORITY desires CONTRACTOR to continue to perform Services as may be specifically designated and authorized by the AUTHORITY.

**Now, therefore**, in consideration of the foregoing and the mutual promises and covenants contained herein, and other good and valuable consideration, the receipt of which is acknowledged by the other, the Parties hereto agree as follows:

In accordance with Article 1 – Effective Date and Incorporation of Recitals, the AUTHORITY and the CONTRACTOR mutually agree to extend the Agreement for above written services on the same terms and conditions for an additional three (3) years effective **May 8, 2025 through May 7, 2028**.

All other provisions of the Agreement for the services as written above dated the 25th of April 2022, shall remain in full force and effect and shall not be altered, amended or rescinded except as provided herein.
