12 13	WHEREAS, the United States Department of Housing and Urban Development (HUD) has determined that Wellington qualifies as an "entitlement recipient" and is			
13 14	eligible to receive funds under the Community Development Block Grant (CDBG)			
15	program; and			
16				
17	WHEREAS, the primary objective of HUD in awarding CDBG funds is to develop			
18 19	viable communities by providing funding and programs to ensure decent housing, suitable living environments, and expanded economic opportunities, principally for low			
19 20	and moderate income persons; and			
21				
22	WHEREAS, in accordance with 24 CFR 91.105, Code of Federal Regulations,			
23	Wellington has previously adopted a Citizen Participation Plan (CPP) to encourage			
24 25	citizen participation in the preparation of the Five-Year Consolidated Plan and Annual			
25 26	Action Plan to allocate the CDBG funding; and			
20 27	WHEREAS, Wellington's adopted CPP establishes criteria constituting			
28	substantive amendments to the Five Year Consolidated Plan and Annual Action Plan			
29	and outlines a process for amending the Five Year Consolidated Plan and Annual			
30	action Plan which encourages citizen participation (especially by persons of low- and			
31 32	moderate-income), provides citizens with reasonable and timely access to local meetings and information, provides for technical assistance, provides for public			
33	hearings and provides for a complaint procedure; and

35	WHEREAS, Wellington is in compliance with its adopted CPP and proposes			
36 27	adding one new activity to the FY 2013/2014 Annual Action Plan which was not			
37 38	previously identified to be assisted with CDBG to be assisted with CDBG funds; and			
39	WHEREAS, Wellington must adopt this Amendment to the FY 2013/2014 Annual			
40	Action Plan prior to obligating or expending CDBG funds for previously unidentified			
41	activities.
