10 **SECTION 2**: The Manager is hereby directed to amend the Wellington Zoning 11 Map to designate the FLUM designation as Mixed Use Type 1, include an adopted date 12 and ordinance number in accordance with this Ordinance.

13 <u>SECTION 3</u>: Should any section, paragraph, sentence, clause, or phrase of this 14 Ordinance conflict with any section, paragraph, clause or phrase of any prior Wellington 15 ordinance, resolution, or municipal code provision, then in that event the provisions of 16 this Ordinance shall prevail to the extent of such conflict.

17 **SECTION 4:** Should any section, paragraph, sentence, clause, or phrase of this 18 Ordinance be declared by a court of competent jurisdiction to be invalid, such decision 19 shall not affect the validity of this Ordinance as a whole or any portion or part thereof, 20 other than the part so declared to be invalid.
