**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL
APPOINTING NEW SPECIAL MAGISTRATE(S) IN
ACCORDANCE WITH SECTION 2-42 OF WELLINGTON'S
CODE OF ORDINANCES; AND PROVIDING AN EFFECTIVE
DATE.**

WHEREAS, the Wellington Council may appoint Special Magistrates to hear and decide cases involving code violations pursuant to Chapter 2 of Wellington's Code of Ordinances and Chapter 162 of the Florida Statutes; and

WHEREAS, section 2-42 of the Code of Ordinances permits the Wellington Council to appoint one (1) or more persons as Special Magistrate for an initial two (2)-year term pursuant to the selection process enumerated therein, and outlines procedures for reappointment, compensation, suspension, and removal; and

WHEREAS, Wellington presently has three Special Magistrates serving staggered terms with one magistrate's term expiring on June 30, 2025 and the Wellington Council believes it is in the best interest of the Village of Wellington to appoint one or more additional Special Magistrates; and

WHEREAS, Wellington staff initiated the selection process enumerated in section 2-42 of the Code and received four (4) applications for Special Magistrate; and

WHEREAS, staff now submits the applications for the Council's consideration and recommends the appointment of one or more Special Magistrates, to serve a two (2)-year term from _____, 2025 to _____, 2027 at the hourly compensation rate of \$200.00.

NOW THEREFORE BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL THAT:

SECTION 1. The above recitals are hereby affirmed and ratified as being true and correct.

SECTION 2. The Wellington Council hereby appoints _____ as Special Magistrate(s) to serve a term of two (2) years from _____, 2025 through _____, 2027 at the hourly compensation rate of \$200.00.

SECTION 3. This Resolution shall be effective immediately upon adoption.
