**ORDINANCE NO. 2024-17**

**AN ORDINANCE OF WELLINGTON, FLORIDA'S COUNCIL,  
AMENDING THE WELLINGTON CODE OF ORDINANCES TO  
UPDATE THE REFERENCES IN SECTION 2-47. – VIOLATIONS  
AND PENALTIES, AS MORE SPECIFICALLY CONTAINED  
HEREIN; PROVIDING A CONFLICTS CLAUSE; PROVIDING A  
SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the Wellington Council, as the governing body, pursuant to the authority vested in it by Chapter 162, Part II, Florida Statutes, is amending the Code of Ordinances to update the code references for violations and penalties; and

**WHEREAS**, Section 2-47 of the Code of Ordinances identifies the class of violations and the associated penalties and requires updating to be consistent with recent amendments to the Code of Ordinances; and

**WHEREAS**, Wellington's Council has taken the comments from the public into consideration of the proposed amendments that are the subject of this Ordinance.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF WELLINGTON, FLORIDA THAT:**

**SECTION 1.** Section 2-47. – Violations and Penalties, of the Code of Ordinances, Wellington, Florida, is hereby amended as specifically provided in Exhibit A.

**SECTION 2.** Should any section, paragraph, sentence, clause, or phrase of this ordinance conflict with any section, paragraph, clause, or phrase of any prior Wellington ordinance, resolution, or municipal code provision, then in that event, the provisions of this ordinance shall prevail to the extent of such conflict.

**SECTION 3.** Should any section, paragraph, sentence, clause, or phase of this ordinance be declared by a court of competent jurisdiction to be invalid, such decision shall not affect the validity of this ordinance as a whole, or any portion of part thereof, other than the part so declared to be invalid.
