Pursuant to the foregoing notice, a Regular Meeting of the Wellington Council was held on Tuesday, June 24, 2025, commencing at 6:30 p.m. at Wellington Village Hall, 12300 Forest Hill Boulevard, Wellington, FL 33414.

- 1. CALL TO ORDER Mayor Napoleone called the meeting to order at 6:30 p.m.
- **2. INVOCATION** Deacon Bob Rodriguez, St. Therese de Lisieux Catholic Church, delivered the invocation.
- 3. PLEDGE OF ALLEGIANCE Mayor Napoleone led the Pledge of Allegiance.
- 4. APPROVAL OF AGENDA

Mr. Barnes indicated staff recommended approval of the Agenda as amended.

A motion was made by Vice Mayor Siskind, seconded by Councilwoman Silvestri and unanimously passed (5-0), to approve the Agenda as amended.

Mr. Barnes introduced the item.

Representative Anne Gerwig, District 93, stated this has been a challenging and rewarding experience. Representative Gerwig provided the Village Council with a summarization of her sponsored bills, co-sponsored bills and commented about the state budget.

The Village Council gave comments, asked questions and thanked Representative Gerwig for her service, update and attendance.

This item was discussed prior to Item 6A.

Mr. Barnes introduced the item.

Ms. Hall read each of the three Resolutions by title.

Ms. Quickel stated she was presenting the preliminary proposed Fiscal Year 2026 Budget and TRIM overview. She said Wellington's budget process starts with the Five Fundamentals: Neighborhood Renaissance, Economic Development, Protecting Our Investment, Responsive Government, and Respecting the Environment. She stated staff then developed the budget using insights and information from the 2025 Directions Workshop with the Village Council.

Ms. Quickel highlighted the budget priorities: Deliver Essential Services Efficiently, Support Community Priorities, Fund Operations and Maintenance of Expanded Facilities while Minimizing Tax Impacts and Responsibly Invest in Wellington's Future.

Ms. Quickel indicated staff is proposing no change to the ad valorem millage rate from this year and for it to remain at 2.47 mills. This is the average rate for the last seventeen years. She said staff recommends the proposed ACME non-ad valorem assessment rate of \$275 per unit; which is a \$20 increase from the current rate of \$255. This was discussed extensively during a portion of the Directions workshop.

Ms. Quickel indicated the TRIM rates for the Solid Waste Assessments were previously adopted on June 11, 2025 and were recommended at \$320.00 per curbside unit and \$235.00 per containerized unit.

Ms. Quickel stated the Water & Wastewater average bill would increase monthly by approximately \$8.26.

Ms. Quickel stated the Saddle Trail Park Improvement District assessment, only for those properties within Saddle Trail that received these benefits, is \$1,721 per acre. She said this is the tenth year of that fifteen (15) year term for that assessment. Ms. Quickel stated the rate is the same as last year.

Ms. Quickel stated the proposed budget is \$155.7 million, which is \$6.7 million more than the current year budget of \$149 million She said this \$6.7 million increase is primarily due to capital improvements, enhanced public safety and continued resident programs and services. Detailed information will be presented at the upcoming Capital Projects workshop in August.

Ms. Quickel stated that out of the proposed FY 2026 budget of \$155.7 million, tax revenues provide approximately \$31 million in revenues using the proposed 2.47 millage rate. This is the thirteenth consecutive year of increased property values since 2013. The revenue value of each tenth of a mill for FY 2026 is \$1,252,000 million compared to \$1,191,000 million in FY 2025. Ms. Quickel mentioned budget influences in regards to revenues.

Ms. Quickel highlighted governmental sources including transfers and fund balance. She also referenced budget influences in regards to expenditures. Ms. Quickel discussed the budget changes in the Governmental Funds and Enterprise Funds. In addition, she stated Ad Valorem Tax revenue of \$31 million represents 42% of General Fund revenues for FY 2026.

For Capital Projects and Programs, the FY 2026 budget includes One-Time Governmental Projects at \$5,383,689 million. The Ongoing Programs are \$7,170,000 million and the Utility Projects are \$9,190,000 million. Ms. Quickel explained what was included in each category.

Ms. Quickel commented regarding the millage rate and future funding considerations. She said with the proposed 2.47 millage rate, the impact for a homesteaded property valued at \$450,000, would be a \$32.00 increase. For a property that is non-homesteaded, it will be a \$111.00 increase.

Ms. Quickel reviewed a sample tax bill and discussed what to expect in the 2026 Budget. She concluded the presentation with the budget calendar. She noted that staff is focused on public outreach to gain input from residents and stakeholders with multiple engagement options: the Budget Balancing Act and Taxpayer Receipt, Budget Challenge Online Survey, Flash Vote, social media and Wellington's website. The simulation is active from July 7, 2025 to August 21, 2025. She stated the budget and capital workshop is scheduled for Monday, August 11, 2025. Ms. Quickel indicated that staff would receive the Florida Department of Revenue, Office of Tax Research, Municipal Revenue estimates in late July and will make the necessary budget adjustments based on this information. She acknowledged Christine Wadleigh and Rubi Cabret who helped to put the budget together.

Mayor Napoleone reiterated that there are opportunities for residents to provide their input regarding the budget.

The Village Council thanked Ms. Quickel and her team for their work on the budget.

Council gave comments and asked questions regarding property values, the millage rate and budget.

Ms. Quickel answered Council's questions.

Public Hearing

A motion was made by Councilman McGovern, seconded by Councilwoman Silvestri, and unanimously passed (5-0), to approve Resolution No. R2025-45 (Adopting the Preliminary Ad Valorem Millage Rate for Truth-in-Millage (TRIM) Purposes within the Jurisdictional Boundaries of Wellington) setting the TRIM rate at 2.47 mils as presented.

Ms. Cohen stated this is Quasi-Judicial. She swore in the individuals who wished to speak on the item.
