R2022-53** 2 3 A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL 4 APPROVING AND AUTHORIZING THE MAYOR AND 5 CLERK TO EXECUTE THE LAW **ENFORCEMENT** SERVICES AGREEMENT WITH THE PALM BEACH 6 7 COUNTY SHERIFF'S OFFICE FOR LAW ENFORCEMENT 8 SERVICES: AND PROVIDING AN EFFECTIVE DATE. 9 10 11 WHEREAS, since Incorporation, Wellington has contracted with the Palm Beach 12 County Sheriff's Office to provide law enforcement services for the Village of Wellington; 13 and 14 WHEREAS, on August 9, 2022, Council approved the First Addendum to the 15 Law Enforcement Services Agreement (Agreement) effective October 1, 2022, for a 16 17 period of one (1) year, expiring on September 30, 2023; and 18 19 WHEREAS, Article 5.2 of the Agreement provides that the total amount due for 20 all law enforcement services for subsequent years shall be based upon the proposed 21 costs submitted by the Sheriff during Wellington's budget process and approved by 22 Wellington's Council; and 23 24 WHEREAS, the total amount of compensation for the Fiscal Year 2022/2023 was 25 \$10,546,818.00 which reflected 3% increase and adjustments in staffing with the 26 addition of four (4) crossing guards, an increase of \$389,600.70 over the previous year; 27 and 28 29 WHEREAS, the total amount of compensation for the Fiscal Year 2023/2024 is 30 \$10,863,223.00 which reflects a 3% increase for a total increase of approximately \$316,405.00 over the previous year, as set forth in the Law Enforcement Services 31 32 Agreement, attached hereto as Exhibit "A"; and 33 34 WHEREAS, Staff recommends that the Village Council approve the proposed 35 Law Enforcement Services Agreement between the Village of Wellington and the Palm 36 Beach County Sheriff's Office. 37 38 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S 39 **COUNCIL** that:
