The parcel of land is lying in Section 20, 14 15 Township 44 South, Range 41 East, Village of Wellington, Palm Beach County, Florida (Exhibit A – Baxter Hill Gardens Plat Location Map). 16 17 18 WHEREAS, the Baxter Hill Gardens Plat has been reviewed and found to be 19 consistent with the preliminary replat approval for Technical Compliance; and 20 21 WHEREAS, all required documents upon which the replat is based are attached 22 hereto: 23 24 WHEREAS, all necessary dedications and fees have been supplied to the Village 25 of Wellington; and 26 27 WHEREAS, the Engineering Department recommends that Council accept and 28 approve the proposed replat. 29 NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S 30 31 **COUNCIL** that: 32 33 **SECTION 1.** The foregoing recitals are hereby affirmed and ratified as being true 34 and correct. 35 36 **SECTION 2.** The Wellington Council hereby accepts and approves the Baxter Hill Gardens Plat, a copy of which is attached (Exhibit B - Baxter Hill Gardens Plat), and 37 38 hereby authorizes the Mayor and Clerk to execute the plat for recordation, subject to 39 and conditioned upon the requirements of Article 8 of Wellington's Land Development 40 Regulations. 41 42 **SECTION 3.** Upon recordation of the plat, any prior plat encompassing this 43 property or pre-existing subdivision of this property shall be automatically and 44 simultaneously vacated and annulled. 45

SECTION 4. This Resolution shall become effective immediately upon adoption.
