- 1. - 6. The application shall comply with the LDR section 6.4.4.12 Amusements, Temporary or Special Event.
- 7. No alcohol shall be permitted beyond the confines of the event area. No alcohol shall be served to minors under 21 years old.
- 8. Comply with the Wellington Noise Ordinance Chapter 36, Article III, Sec. 36-30 to 36-39.
- 9. Must provide one Palm Beach County Sheriff Officer controlling traffic on Blue Big Trace, and one officer to patrol the festival.
- 10. One (1) sign no larger than 4' x 3' shall be permitted two days prior to the event (March 3<sup>rd</sup>) at the southeast corner of the property and removed immediately after the event.
- 11. This permit does not release the applicant from the need to obtain any other required local, county, state or federal permits/license.
- 12. Wellington shall have the right to inspect the property as long as this permit is valid. This permit shall be posted on site at all times during the event.
