

**SEVENTH ADDENDUM TO THE LAW ENFORCEMENT SERVICE AGREEMENT**  
SHERIFF RIC L. BRADSHAW AND WELLINGTON

This Seventh Addendum to the Law Enforcement Service Agreement is made by and between The Village of Wellington (hereinafter referred to as “Wellington”), located in Palm Beach County, and Ric L. Bradshaw, Sheriff of Palm Beach County, Florida (hereinafter referred to as “Sheriff”). Wellington and the Sheriff shall hereinafter be referred to as the “Parties.”

**WHEREAS**, the Parties executed a Law Enforcement Service Agreement effective October 01, 2014, a First Addendum effective October 01, 2015, a Second Addendum effective October 01, 2016, a Third Addendum effective October 01, 2017, a Fourth Addendum effective October 01, 2018, a Fifth Addendum effective October 01, 2019, and a Sixth Addendum effective October 01, 2020, (the “Agreement”), by which the Sheriff agreed to perform law enforcement services; and

**WHEREAS**, the Parties wish to adjust the level of service by eliminating one (1) Criminal Intelligence Analyst, convert one (1) Criminal Justice Planner to Criminal Intelligence Analyst, convert one (1) K-9 Deputy to Deputy Sheriff, and set forth the adjusted consideration for the remaining Second Year of the Extended Contract Term, beginning July 01, 2021 through September 30, 2021.

**NOW, THEREFORE**, in consideration of the mutual covenants herein contained the receipt and sufficiency of which are hereby acknowledged, it is agreed upon as follows:

1. In accordance with Article 5, Section 5.2 of the Law Enforcement Service Agreement, Section 5.1 is amended as to the total amount due for services for the period beginning July 01, 2021 through September 30, 2021 as follows: The total cost of personnel and equipment shall be \$2,489,514.00. Monthly payments shall be \$829,838.00.
2. In all other respects and unless otherwise stated, the terms and conditions of the Agreement, which includes prior Addenda, shall continue unchanged and in full force and effect.
