

**PETITION TO VILLAGE OF WELLINGTON / ACME IMPROVEMENT DISTRICT FOR
FORMATION OF A UNIT OF DEVELOPMENT**

The undersigned (the "Applicant(s)") hereby request that the Village of Wellington / ACME Improvement District (VOW/ACME) form a Unit of Development for the hereinafter described Real Property and in furtherance thereof, the Applicant(s) do affirmatively acknowledge or state as follows:

1. That the Applicant(s) is authorized to submit this Petition for or on behalf of the fee simple title owner(s) of in excess of sixty-six percent (66%) of the real property described in attached Exhibit "A" (the "Property").
2. That attached hereto is a check payable to VOW/ACME in the amount of \$2,500 which is being provided in order to assist VOW/ACME in defraying those costs and expenses (including legal, administrative, engineering and legal advertisements) as may be incurred in order for VOW/ACME to initiate proceedings for formation of the requested Unit of Development for the Property.
3. That the Applicant(s) is aware that this request for VOW/ACME's formation of a Unit of Development will be subject to a Public Hearing, public comment and consideration by VOW/ACME's Governing Body.
4. That the Applicant(s) acknowledges that if VOW/ACME's Governing Body approves the formation of a Unit of Development for the Property, that the Applicant may be asked to enter into one or more agreements with VOW/ACME prior to any consideration by VOW/ACME of the preparation of a Plan of Improvements (a/k/a "Water Management Plan") for the implementation and/or maintenance of public improvement for the Unit of Development.
5. That the Applicant acknowledges that VOW/ACME's creation of the requested Unit of Development and subsequent preparation and implementation of a Plan of Improvements for same shall be subject to the provisions of VOW/ACME's enabling legislation, ordinances, code, the Laws of Florida, as applicable, and the Applicant(s)'s representations as contained herein.
