**I Call to Order**

Nicole Coates called the meeting to order at 4:00 pm.

**II Pledge of Allegiance**

Nicole Coates led the Pledge of Allegiance.

**III Roll Call**

**IV Opening Comments**

Committee members introduced themselves and gave brief backgrounds to their experience and how they are looking forward to serve this committee.

**A. [PSC-262](#) SELECTION OF CHAIR AND VICE CHAIR**

Michael Arena nominated Michael Weil for the position as Chair of the committee. Robert Chenoweth seconded the nomination.

Ron Herman nominated himself for the Vice Chair position of the committee. Michael Arena seconded his nomination.

The committee voted 6-0 for Michael Weil as Chair and Ron Herman as Vice Chair.

**V Approval of Agenda**

A motion was made by Chair Michael Weil and seconded by Michael Arena and unanimously passed (6-0) to approve the agenda as presented.

## VIII Staff Report

Ms. Coates introduced herself to the committee. She explained her role as being the staff liaison for the Public Safety Committee as well as her day-to-day duties as Emergency Management and Public Safety Director.

She told the committee that if they have any items they wish to have included in the meeting agendas to let her know.

## IX Reports

### A. [PSC-264](#) PALM BEACH COUNTY FIRE RESCUE REPORT

District Chief Amanda Vomero introduced herself to the committee and explained her role and her district. She shared that Wellington has four fire stations. Chief Vomero explained that during the meeting she typically will give the committee the quarterly response time report and updates.

Chief Vomero said that hurricane preparations are underway for the upcoming storm season and Fire Rescue has done all the walk-throughs at all Palm Beach County schools. She went on to share some events that took place through the months of March, April, and May.

Chief Vomero shared that from March 11, 2024 to June 11, 2024, Fire Rescue had 1,682 calls and 75% of the calls were medical. The average response time was 6 minutes, 43 seconds.

Chief Vomero mentioned that if there are any topics the committee would like to hear about, she is more than happy to set up a presentation. Vice Chair Herman asked Chief Vomero if there has been a recent presentation on CPR. Chief Vomero stated she would ask Ms. Coates since she took command in April 2023.

### B. [PSC-265](#) PALM BEACH COUNTY SHERIFF'S OFFICE DISTRICT 8 WELLINGTON REPORT

Sergeant Matthew DeJoy presented on behalf of District 8. He introduced himself to the committee and shared how traffic is one of the major enforcements inside the Village of Wellington. He stated that there are 67 sworn deputies and six non-sworn employees in District 8.

Sergeant DeJoy shared that Wellington is unique from other cities because they have two unmarked traffic cars. He went on to share the quarterly report and that there have been four burglaries to business this year, one burglary to a construction site, ten burglaries in residences, 67 burglaries to vehicles, and 11 recoveries of stolen vehicles.

Sergeant DeJoy shared the traffic statistics with the committee and that the traffics stops are up 1,884 from last year. He went on to give brief updates and statistics to the operations taking place in the Village of Wellington.

The committee members asked the Sergeant if the vehicle crimes are being committed by Wellington residents or people coming from other areas.

**X New Business****A. [PSC-261](#) VISION ZERO UPDATES**

Ms. Coates moved on to the Vision Zero project and shared a brief synopsis of this project. She introduced the Wellington Engineer, Jonathan Reinsvold who spoke to the committee about the outreach that has been done to get resident feedback on Vision Zero and Traffic safety items. Mr. Reinsvold introduced the TJKM consultants, Ruta Jariwala and Anna Hightower who presented virtually.

The consultants spoke about the Wellington Vision Zero plan and the breakdown to what has been done so far through this plan. They shared what safety projects were currently being planned.

Committee members asked questions relating to how the information is given to the Vision Zero team as well as turn lane safety in some areas around the houses of worship off of Big Blue Trace. Questions about the lighting along certain parts of the community were brought up to the consultants and the Village Engineer.

**B. [PSC-263](#) SELECTION OF TOP COP AND TOP FIREFIGHTER FOR 2024**

Vice Chair Ron Herman recused himself from the Top Cop voting due to some work-related matters. Robert Chenoweth nominated Agent McDonald and it was seconded by Matthew Ladd, unanimously passed (6-0) to select Agent Terrance McDonald as the 2024 Top Cop.

Vice Chair Ron Herman nominated Captain Jessica Banks and it was seconded by Chair Michael Weil, unanimously passed (7-0) to select Captain Jessica Banks as the 2024 Top Firefighter.

The committee members commented on the meeting being very informative and they are looking forward to the next meeting and to be working with everyone.
