Hillers Electrical Engineering, Inc. (HEE) is pleased to provide the Village of Wellington (Village) this proposal for professional engineering services for the above referenced project.

Hillers Electrical Engineering (HEE) completed final design of project "WTP M1 Wiring and Raceway Replacement" to replace power, control and signal wiring and raceway between the existing M1 Scrubber-Degasifier Structure and the existing MCC-RO and PLC-RO1 located in the Membrane Building M1. The Village is performing the installation through a Construction Manager at Risk (CMAR) contract and requires engineering support during construction. Our services include: attend pre-construction and monthly construction meetings; review of shop drawing submittals; responding to requests for information, contract clarifications and review of contractor change orders; review of pay requests, specialty inspections for electrical systems; substantial and final completion inspections; witnessing start-up and testing; preparation of record drawings from contractor redline markups; and engineering support during construction. Construction duration is anticipated to be one hundred-fifty (150) days after contract award to the contractor.
