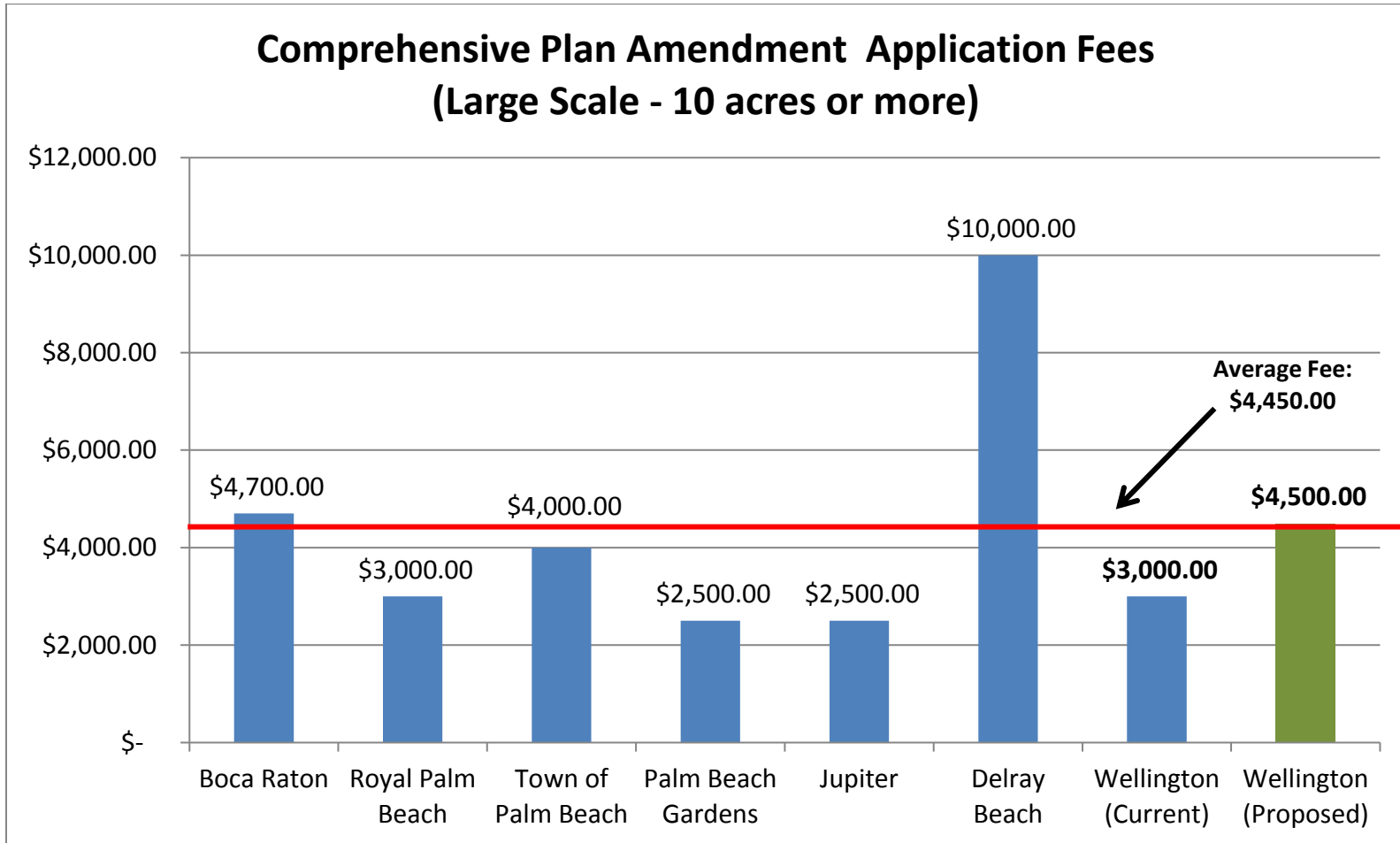


Exhibit B – Planning and Zoning Fee Comparison Graphs

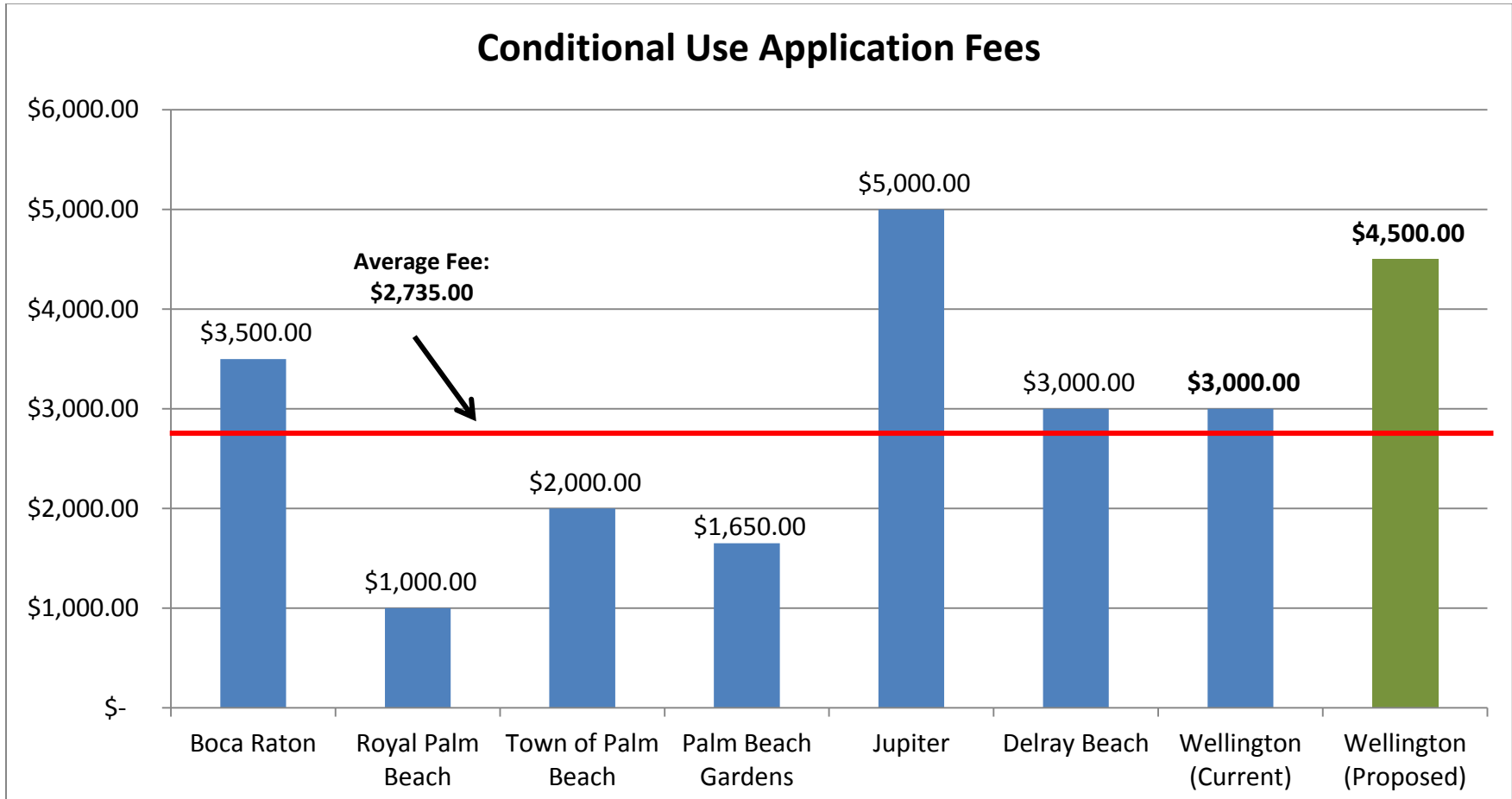

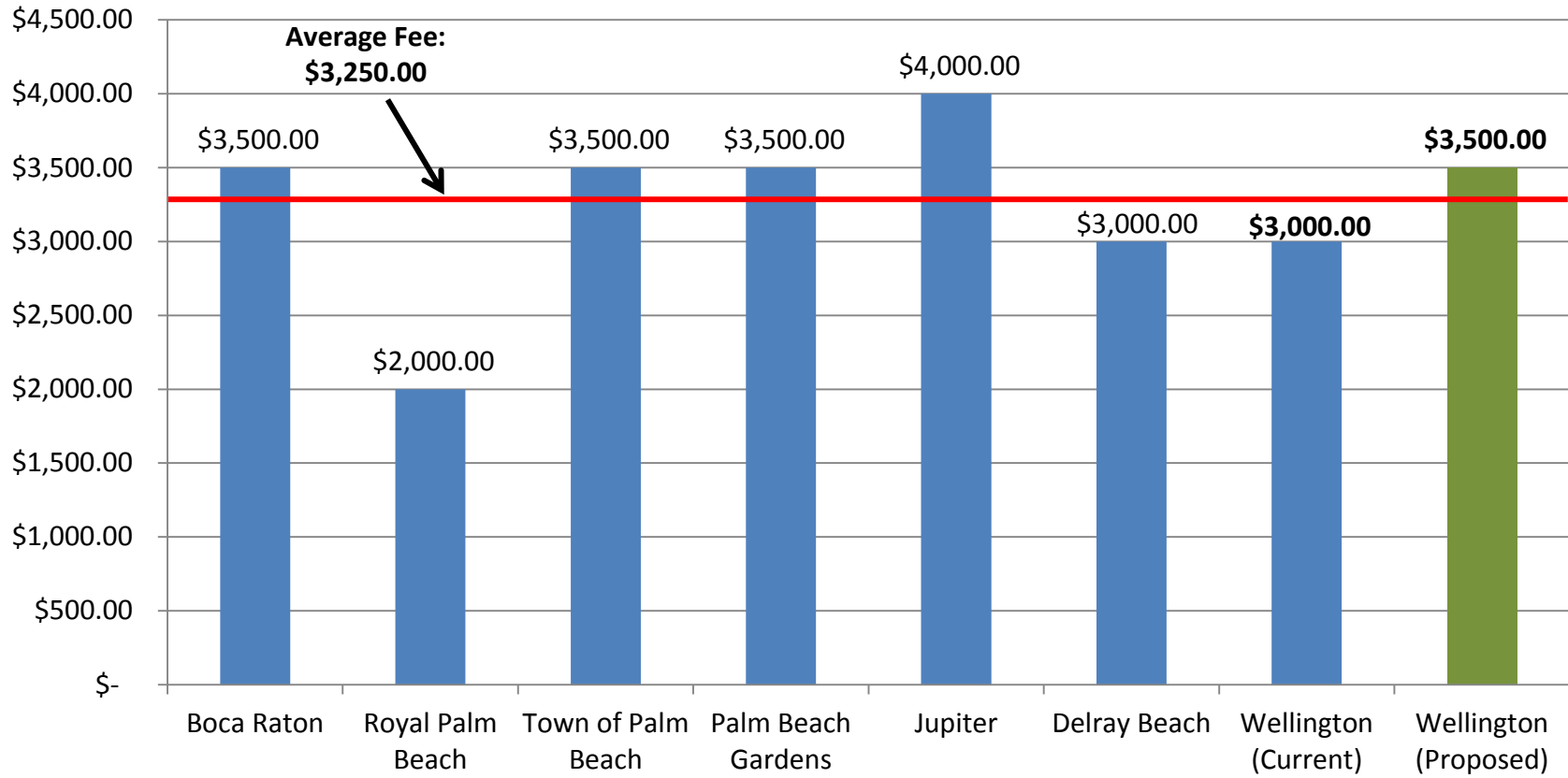

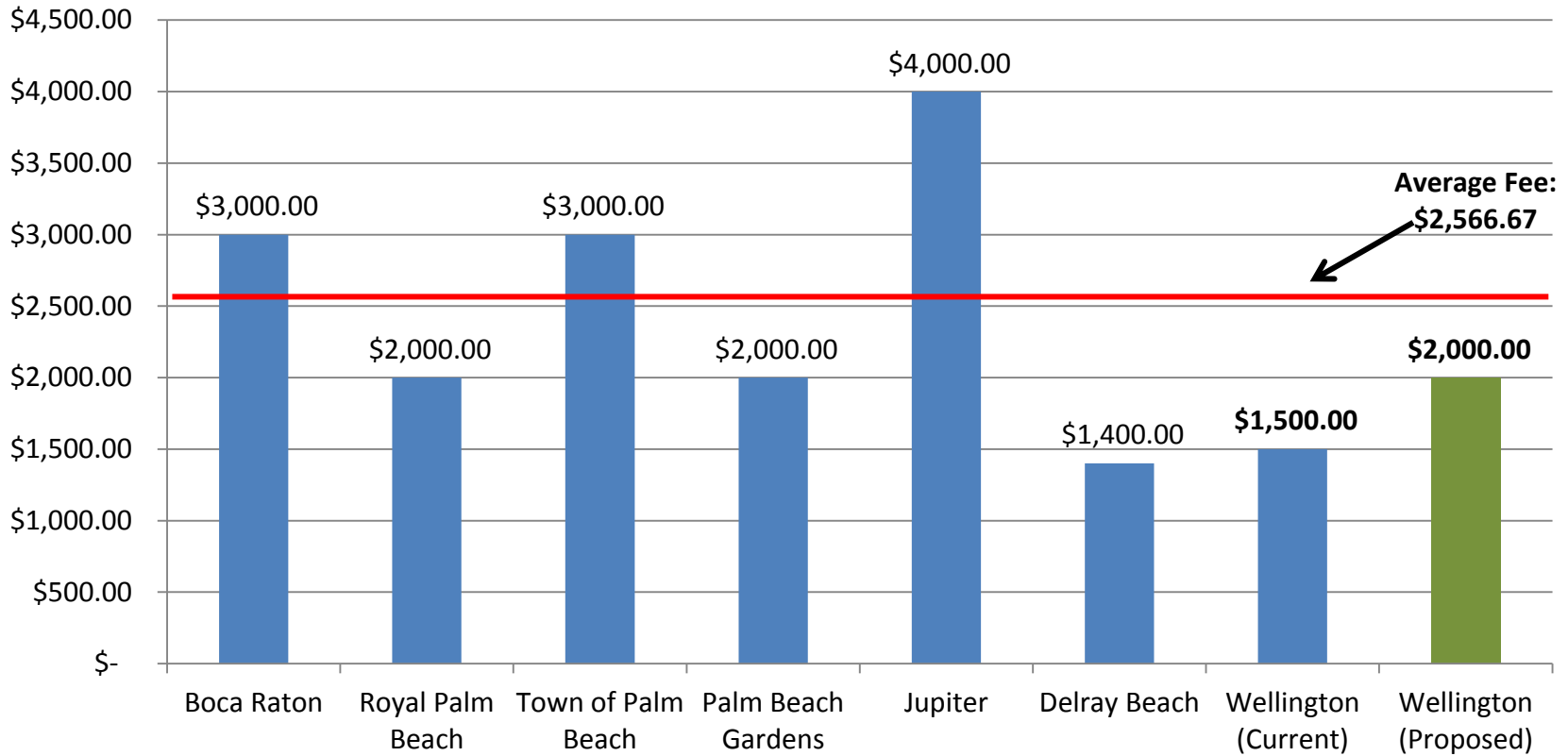

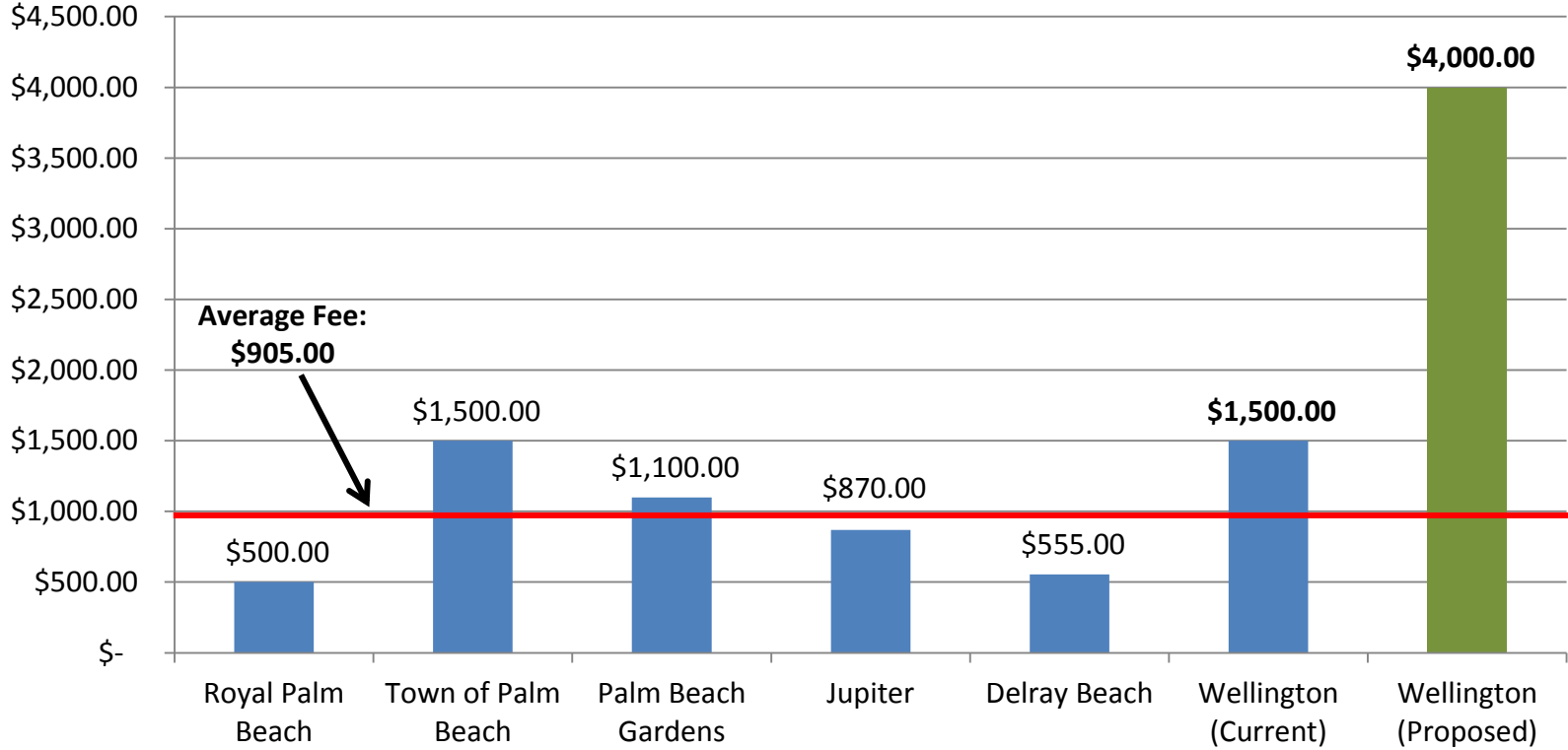

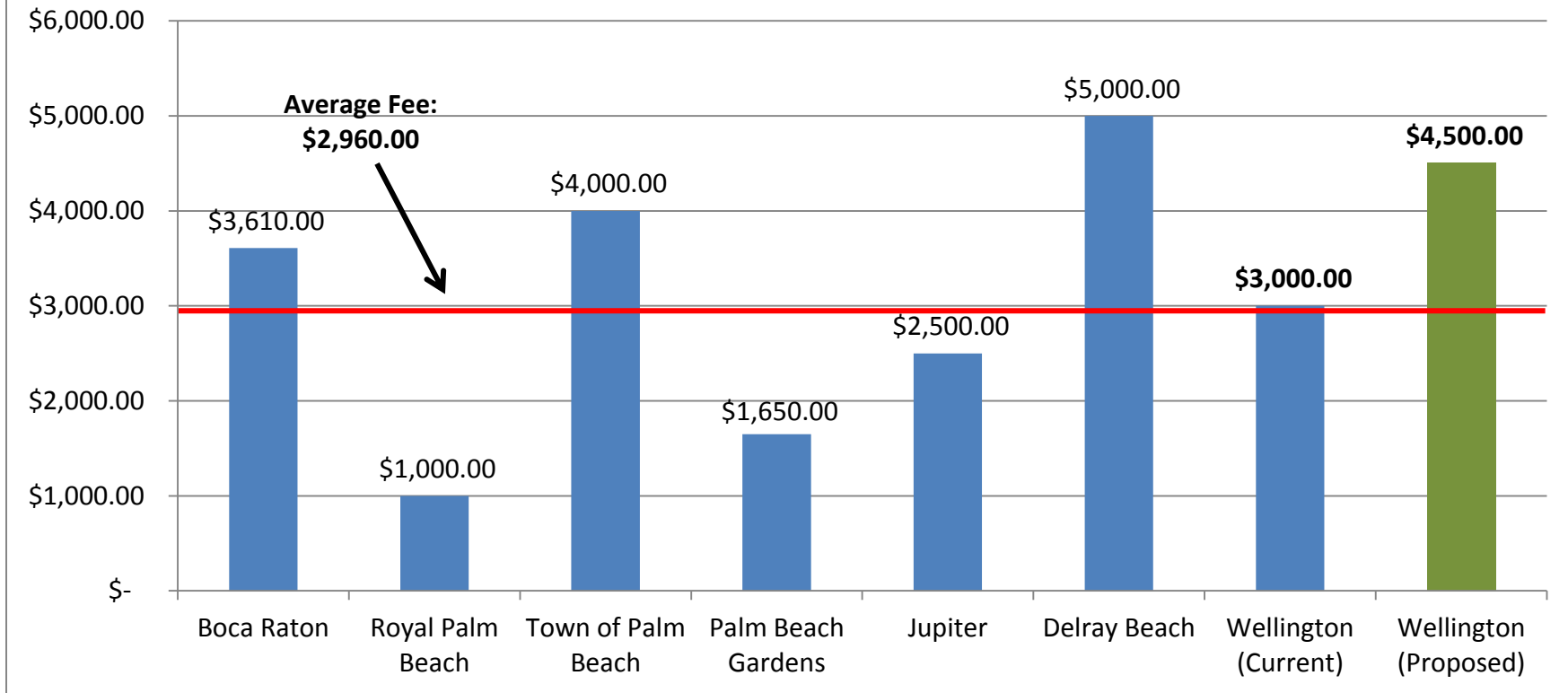
