FISCAL YEAR 2015 ANNUAL ACTION PLAN SUBSTANTIAL AMENDMENT #1

The Village of Wellington is an entitlement recipient of Community Development Block Grant (CDBG) funds authorized under Title I of the Housing and Community Development Act of 1974, as amended (Public Law 93-383, as amended).

Consistent with the Citizen Participation requirements at 24 CFR Part 91.105 and the Citizen Participation Plan developed by the Village of Wellington, the Village will substantially amend its approved Consolidated Plan and One Year Action Plan when it proposes:

- A. To make a change in the allocation priorities or a change in the method of distribution funds;
- B. To carry out an activity using funds from any program covered by the Consolidated Plan (including program income), not previously described in the Annual Action Plan;
- C. To change the original intent and purpose of an activity which is no longer applicable;
- D. The costs associated with a change in the scope of an activity increase or decrease by fifty-one percent (51%);
- E. The location of an activity changes to the extent that it does not serve the target population as originally described in the Consolidated Plan.

Activities proposed to be deleted from the FY 2015 CDBG Annual Action Plan:

- (1) Public Facilities/Feasibility Study for Senior Center.....\$12,500
- (2) R.E.A.C.H. Youth Recreation Scholarship Program.....\$13,000
- (3) Boys and Girls Club Neighborhood Outreach Efforts.....\$10,790
- (4) S.O.A.R Tuition and Education Assistance Program.....\$ 5,000

Activities proposed to be added to the FY 2015 CDBG Annual Action Plan:

- (1) Housing Rehabilitation Program.....\$47,500
- (2) Youth Mentoring and Internship Program.....\$13,000
- (3) Urban League of Palm Beach County; Fair Housing Education, Outreach and Referral,  
Foreclosure Mitigation and Prevention and Youth Outreach Programs.....\$15,790

PUBLIC COMMENT: The 30 day public comment period will commence on December 15, 2014 and end on January 13, 2015. The above described changes comprise the entire Substantial Amendment to the Village of Wellington’s FY 2015 Annual Action Plan.
