- **2. INVOCATION** Deacon Pete Del Valle, St. Therese de Lisieux Catholic Church, delivered the invocation.

Mayor Napoleone commended Ms. Quickel and her team for a thorough and well prepared presentation.

Mr. Barnes introduced the item.

Ms. Hall read Ordinance No. 2025-25 by title.

Tim Stillings, Director of Planning and Zoning, stated this proposed ordinance addresses Senate Bill 1388 that was passed into law in May 2025. He said the bill adopted the "Watercraft Energy Source Freedom Act". Mr. Stillings explained the proposed amendment.

Ms. Cohen referenced the law and no idle/no wake speed.

Mayor Napoleone provided comments about the law that was passed.

Councilman McGovern asked about a sunset provision being placed in the ordinance.

Councilwoman Silvestri asked Ms. Cohen to explain to the audience what the options are if they need to make a complaint.

There was discussion between the Village Council, Mr. Barnes, Ms. Cohen and Mr. Stillings regarding the legislation that was passed and the ordinance.

Public Hearing

A motion was made by Councilman McGovern, seconded by Vice Mayor Siskind, and unanimously passed (5-0) to open the public hearing.

Public Comment:

- 1. Michael Imber spoke about the ordinance in terms of enforcement and the environmental impact.
- 2. Klaus Renner (sp?) stated he is concerned about the environmental impact.
- 3. Jack Brownson stated he has lost more than 4 feet of his shoreline. He stated the entire lake has lost shoreline. He asked if there is a way to restrict and not allow jet skis. He mentioned the rowing club, paddle boarders and kayaks.
- 4. Bijay Kattel is opposed and spoke regarding the lake and enforcement.
- 5. Susan Ashe spoke about the \$25 fee permit, enforcement, and number of boats allowed.
- 6. Elizabeth Pandich discussed zoning for the lake.

Vice Mayor Siskind read the cards into the record of those who opposed but did not wish to speak (Ron Schwartz, Gary Swedenborg, Esther Gambaro, Annie Inzerillo, Paula Brownson, and Holly Chaney).

There being no further public comments, a motion was made by Councilman McGovern, seconded by Councilwoman Silvestri, and unanimously passed (5-0), to close the public hearing.

There was further discussion about cordoning off certain areas of the lake, permits, signage, and possible zoning.

Councilman McGovern stated he is opposed to gas motors on Lake Wellington but will move approval because the Village has no choice.

A motion was made by Councilman McGovern, seconded by Councilwoman Antuña and unanimously passed (5-0) to Approve Ordinance No. 2025-22 (Amending Chapter 24 Waterways) on first reading.

Mr. Stillings said this is second reading readoption for the comprehensive plan amendment for Marjory Stoneman Douglas Preserve (Section 24) and is a land use amendment changing the land use from the County designation to a Wellington designation. He spoke about the time requirement.

Ms. Hall read Ordinance No. 2025-08, Resolution No. R 2025-15 and Resolution No. R2025-16 by title.

Ms. Cohen stated two of the items are Quasi-Judicial. She swore in the individuals who wished to speak on the item.

Councilwoman Silvestri: Councilwoman Silvestri stated she had spoken with staff, Doug McMahon, Paige Nuñez, Stacy Lima, John Bowers, Maureen Brennan, Palm Beach County Commissioner Sara Baxter, Johnny Meier, Stephen Levin, Jessica Duncan and Richard Silvestri. She said she could be fair and impartial.

Vice Mayor Siskind: Vice Mayor Siskind stated she had spoken with Paige Nuñez. She said she could be fair and impartial.

Mayor Napoleone: Mayor Napoleone disclosed that he had spoken with the applicant and their team, staff, residents via email, his wife, and Stephen Levin. He said he could be fair and impartial.

Councilman McGovern: Councilman McGovern disclosed he had spoken with staff, the applicant and their team, John Bowers, Michael Drahos, Jeff Robbert, Satesh Raju, Stephen Levin and his wife. He said he could be fair and impartial.

Councilwoman Antuña: Councilwoman Antuña stated she had spoken with staff, Doug McMahon, Paige Nuñez, Anna Sanchez, Flora Perez, Dr. Dexter DiMarco, Dr. Cynthia DiMarco, Mary Lou Bedford, and Stephen Levin. She said she could be fair and impartial.

Kelly Ferraiolo, Senior Planner, entered the files into record and stated the agent and the applicant for the project will make their presentation first.

Douglas McMahon, CEO & Managing Partner/Wellington Lifestyle Partners (Applicant), thanked their team Miskel Backman LLP, Sexton Engineering, Simmons & White, and Cotleur Hearing. He provided brief overview and update about the project.

Donaldson E. Hearing, Owner and President/Cotleur & Hearing (Agent), on behalf of the applicant, spoke about some of the technical aspects of the petitions (comprehensive plan amendment, conditional use and master plan amendment) before Council. He commented about the project context and history, project location and adjacencies, and showed Council a graphic

of the existing and proposed future land use. Mr. Hearing referenced the Wellington PUD – Proposed Master Plan, Project Standards Manual, buffers for the site and proposed Marketplace Project Information.

Mr. McMahon referenced the conceptual site plan and visuals of the project including offices, hotel, shops/restaurants and residences. He highlighted the uses, project connectivity and merchandising, positive financial impacts to the Village and circulation plan.

Brian Kelly, P.E., Traffic Engineer/Simmons & White, briefly spoke about ongoing projects by WLP. He discussed the traffic review and analysis, parking & contingency plan, circulation plan - entrance and exit points, and Greenview Shores Boulevard exiting traffic.

There was discussion between the Village Council, Ms. Cohen, Mr. Stillings, Mr. Kelly and Andrea Troutman (P.E., Founding Partner and President/Pinder Troutman Consulting, Inc.) about parking, traffic, the different types of uses, turn lanes, stacking, proportionate share contributions, previous approvals, peak hours, some changes to the language for the master plan amendment conditions (Condition 32A and Condition 32B regarding peak hours/times for the equestrian shows).

Ms. Ferraiolo reviewed the applicant's request and provided background information. Regarding the Comprehensive Plan Amendment (CPA), she showed a graphic of the current Future Land Use Map (FLUM) which shows the property as Commercial and the proposed FLUM that shows the property as Mixed-Use. She discussed the Conditional Use and Master Plan Amendment, staff analysis, and findings of fact. The Planning, Zoning and Adjustment Board (PZAB) recommended approval of all requests at their May 21, 2025 meeting. Council approved the CPA on first reading at the June 10, 2025 meeting. Ms. Ferraiolo discussed the additional conditions of approval that have been added to the Master Plan Resolution per Council discussion at the June meeting.

The Village Council asked various questions about what could be built on the site currently without Council approval, timeframe of previous approvals, and conditions of approval.

Mr. Stillings, Ms. Ferraiolo and Mr. McMahon responded to Council questions.

Public Hearing

A motion was made by Councilman McGovern, seconded by Vice Mayor Siskind, and unanimously passed (5-0) to open the public hearing.

Public Comment:

- Jamie Freeman stated she thinks the 4 schools near this project (New Horizons Elementary School, Wellington Community High School, Polo Park Middle School and Panther Run Elementary School) are being ignored in terms of traffic. She commented about the staff report pertaining to the capacity for schools.
- 2. Joanne Weiner read a statement into record regarding private tutoring and said they will be displaced during the project. She stated she met with the developers and she is encouraged by their response.
- 3. Larry Unger expressed his concerns regarding the project, parking and traffic.
- 4. Gail Tower spoke about the noise, construction of the project and safety. She said she does not want hotels and strangers around them.

- 5. Angel Perez spoke regarding the project and jobs, affordability of units, parking, traffic, hotel, mixed use Pod. He asked Council to vote no and asked for due diligence.
- 6. Larry Falk, Triple Crown Group, stated he is here to show his support for the Marketplace.
- 7. Elizabeth Pandich expressed her concerns about traffic monitoring.

Vice Mayor Siskind read the following cards of those who did not wish to speak into the record: Anthony Calle (supports), Claro Funes (supports), Michael Bellissimo (supports), Santiago Avendano (supports), Walter Imperatore (supports), James R. Gray (supports), James Faloni (supports), and Kelsey Cruciotti (supports).

There being no further public comments, a motion was made by Councilwoman Silvestri, seconded by Councilman McGovern, and unanimously passed (5-0), to close the public hearing.

Additional discussion took place between the Village Council, Mr. Barnes, Ms. Cohen, Mr. McMahon, Ms. Troutman, Mr. Stillings and Ms. Ferraiolo about school capacity, mitigation during the construction of the project, parking monitoring, Greenview Shores turn lanes, traffic improvements, conditions of approval, hotel amenities, design of the project, and the master plan in terms of units and the 35 feet height, and construction timeline.

A motion was made by Councilman McGovern, seconded by Vice Mayor Siskind, and unanimously passed (5-0) to approve Ordinance No. 2025-08 (The Marketplace At The Wellington CPA) as presented on second reading.
