**Background**  
 Over the past year, all 10 elements of Wellington’s Comprehensive Plan have been reviewed by the Planning, Zoning and Adjustment Board (PZAB) and are tentatively scheduled to be adopted by the Wellington Council on August 10, 2021. The Comprehensive Plan and the Land Development Regulations are required by Florida Statutes to be consistent with each other. The proposed Zoning Text Amendment updates Article 6 of Wellington’s LDR for consistency with the soon to be adopted Comprehensive Plan. Modifications to the existing Article 6 are provided in strikethrough/underline format in Exhibit A and a list of changes to specific sections is provided in Exhibit B.

- Proposed changes to Article 6 include:
- Modifications to the Building Height requirements that were removed from the Comprehensive Plan;
  - Modifications to Table 6.2-1 Use Regulations Schedule to ensure all existing Zoning Districts are listed on the table;
  - Modifications to the Supplemental Use Standards for Home Occupations to be consistent with the recently adopted Senate Bill 266; and
  - Various formatting, editing, and verbiage clarification updates throughout the Article.

**Planning and Zoning Division Recommendation**  
 The Planning and Zoning Division recommends approval of Ordinance No. 2021-12 to modify Article 6 of Wellington’s LDR for consistency with the updates to the newly adopted Comprehensive Plan.
