**A RESOLUTION OF WELLINGTON, FLORIDA'S COUNCIL  
APPROVING A SPECIAL USE PERMIT FOR JUANITO'S  
RESTAURANT, LLC, OPERATING AS THE GRILLE, UTILIZING  
OUTDOOR AMPLIFIED MUSIC TO BE HELD AT 12300 SOUTH  
SHORE BOULEVARD; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, Juanito's Restaurant, LLC, operating as The Grille, located at 12300 South Shore Boulevard in the Wellington Planned Unit Development (PUD), will be hosting a charity talent show benefiting the United States Equestrian Federation in the covered outdoor patio area on Wednesday, March 11<sup>th</sup>, 2015 from 6:30 p.m. to 9:30 p.m.; and

**WHEREAS**, The Grille has an approved Extended Hours of Operation Permit (2013-001) and approved Conditional Use for a cocktail lounge (Resolution R2012-47) requiring any activity outdoors other than outdoor service require a Special Use Permit; and

**WHEREAS**, the event is for five events with live entertainment including outdoor amplified music; and

**WHEREAS**, the event is anticipated to have approximately 350 people in attendance; and

**WHEREAS**, Article 5, Chapter 5. Special Use Permits, Section 5.5.2 of the Wellington Land Development Regulations requires the Council to review all Special Use Permits with amplified music; and

**WHEREAS**, the Special Use Permit application has been reviewed by Wellington staff, Palm Beach Sheriff's Office, Palm Beach County Fire Rescue, and is recommended for approval.

**NOW, THEREFORE, BE IT RESOLVED BY WELLINGTON, FLORIDA'S COUNCIL** that:

**SECTION 1.** The foregoing recitals are hereby affirmed and ratified.

**SECTION 2.** The Wellington Council hereby approves the Special Use Permit (Exhibit A) allowing Juanito's Restaurant, LLC, operating as The Grille, to host a charity talent show in the covered outdoor patio area on Wednesday, March 11<sup>th</sup>, 2015 from 6:30 p.m. to 9:30 p.m.

**SECTION 3.** This Resolution shall become effective immediately upon adoption.
